ENACTED BY EKITI STATE HOUSE OF ASSEMBLY AS FOLLOWS:

Amendment of Title.

- Title*
1. The Title is hereby amended by adding “Ekiti State” before “Urban and Regional Planning and Development Law” to read:

“Ekiti State Urban and Regional Planning Development (Amendment) Law.”

Amendment of Section 46 (2) (a) of the Principal Law

2. Section 46(2) (a) of the Principal Law is hereby amended by substituting the phrase “full time Chairman” with “Part-time Chairman” and by substituting the phrase “Town Planning or related discipline “with physical planning and/or building profession to now read:

Section 46(2) (a):

A part time Chairman, who shall be a holder of a recognized qualification and professional registration in Physical Planning and/or Building profession, shall be the head of the Renewal agency.

Amendment of Section 46(2) (b) of the Principal Law

3. Section 46(2) (b) of the Principal Law is hereby amended by substituting the phrase “other full” with “Part time” to now read:
Board of the Agency. Section 46(2) (b): Two part-time members.

Amendment of Section 46(2) (e) of the Principal Law

4. Section 46(2) (e) of the Principal Law is hereby amended by substituting the words “an Executive Secretary” with the words “a General Manager” to now read as follows:
Board of the Agency Section 46(2) (e): There shall be a General Manager for the Renewal Agency...

Amendment of Section 49(2) of the Principal Law

5. Section 49(2) of the Principal Law is hereby amended by substituting the word “of” with “at” to now read as follows:
Tenure Of Office Section 49(2): “Any public officer appointed to be official member shall hold office as such at the pleasure of the Governor.
