This applies to all institutions including governmental, financial and other commercial institutions. Additionally, for the security purposes of any financial information being sent, the institution's Information Technology (IT) personnel can lock the information as a JPEG in a Microsoft Word document and send the information to the Editor in that prescribed manner.

#### NOTICE OF THE BOARD (NO. 4 OF 2020)

Pursuant to Regulation 5A paragraph 14 of the Public Health Act (Dangerous Infectious Disease) (Amendment) (No.4) Regulations 2020

IN ACCORDANCE WITH paragraph 14 of Regulation 5A of the Public Health Act (Dangerous Infectious Disease) (Amendment) (No. 4) Regulations 2020, the Board with the approval of the Cabinet hereby makes the following modifications to Regulation 5A.

#### 1. Paragraph 4 – Closure of all businesses and exceptions

Subparagraph (3) dealing with businesses permitted to open and operate between the hours of 6:00a.m and 6:00p.m each day is modified as follows by adding after clause (o) the following new category of permitted businesses –

"(p) all retail businesses;"

#### 2. Paragraph 12 - Closure of Beaches

Paragraph 12 is modified by way of a repeal and replacement of the rule regarding beaches with effect from Tuesday 5th May, 2020 at 6:00a.m. as follows –

#### "Paragraph 12 - Permitted use of Beaches

(1) No person is permitted to picnic, consume alcohol, food or play music on any beach for the duration of the curfew period.

(2) A person is permitted to utilise the beach from Monday to Friday only and between the hours of 6:00a.m to 6:00p.m each day for a therapeutic purpose.

(3) Sailing is permitted for the purpose of fishing, provided there are no more than five (5) persons on board the sailing vessel and, in any event, persons on board the vessel are able to practice the social distancing protocols by maintaining a distance of six (6) feet between occupants at all times.

(4) This modification of paragraph 12 shall take effect from Tuesday 5th May, 2020 at 6:00a.m."
