**REGISTERED LAND (FILING FEES) ORDER** made by the Minister in exercise of the powers contained in section 158 of the Registered Land Act Cap. 374.

#### 1. Citation

This Order may be cited as the Registered Land (Filing Fees) Order, 2020.

### 2. Filing Fees

The Minister responsible for Legal Affairs, in exercise of the powers contained in Section 158 of the Registered Land Act has amended Schedule 4 of the Registered Land Rules by prescribing the following new filing fees –
