## Part 1—Preliminary

#### 1 Name

This instrument is the Australian Renewable Energy Agency Regulations 2025.

#### 2 Commencement

#### **3** Authority

This instrument is made under the *Australian Renewable Energy Agency Act* 2011.

#### 4 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### **5** Definitions

Note: A number of expressions used in this instrument are defined in the Act, including the following:

- (a) ARENA;
- (b) Climate Change Convention;
- (c) financial assistance.

In this instrument:

Act means the Australian Renewable Energy Agency Act 2011.

*Clean Energy Innovation Fund* means the fund known as the Clean Energy Innovation Fund that is administered by the Clean Energy Finance Corporation

in accordance with any directions made under subsection 64(1) of the *Clean Energy Finance Corporation Act 2012*.

*clean energy technologies* has the same meaning as in the *Clean Energy Finance Corporation Act 2012*.

#### Section 6

### Part 2—Australian Renewable Energy Agency

#### 6 ARENA's prescribed functions—Clean Energy Innovation Fund

For the purposes of paragraph 8(f) of the Act, ARENA has the following additional functions:

- (a) to assist the Clean Energy Finance Corporation in the governance, management and administration of the Clean Energy Innovation Fund in relation to clean energy technologies;
- (b) without limiting paragraph (a) of this section, to do the following:
  - (i) provide assistance to persons developing project proposals for financing from the Clean Energy Innovation Fund;
  - (ii) provide advice to the Clean Energy Finance Corporation in relation to such proposals.

#### 7 Amounts available for payment to ARENA

Amount for 2037-2038 financial year

(1) For the purposes of item 14 of the table in subsection 64(1) of the Act, the amount prescribed for the 2037-2038 financial year is \$50,000,000.

Additional amounts

(2) For the purposes of subsection 64(2) of the Act, an amount specified in column 2 of an item (the *relevant item*) of the following table is prescribed for the purposes of the item of the table in subsection 64(1) of the Act that is specified in column 1 of the relevant item.
