The Minister, in exercise of the powers conferred by sections 36, 37 and 38 of the Animal Protection and Control Act, makes the following Regulations —

1. Citation.

These Regulations may be cited as the Animal Protection and Control (Ticket) Regulations, 2023.

2. Ticket.

The ticket pursuant to sections 37, 38, 41 and the Second Schedule of the Animal Protection and Control Act (*Ch. 378*) shall be in the Form as set out in the Schedule.
