2. Regulation 37 of the principal Regulations is amended
by—

(a) repealing sub-regulation (3) and substituting
the following—

“(3) A person applying for a Fisherman’s
Licence under sub-regulation (2:01) shall
submit to the Fisheries Administrator—

(a) a completed application form;

(b) the prescribed application fee; and

(c) any of the following—

(i) a valid Belizean Passport;

(ii) a valid Belizean Voters
Identification Card or Social
Security Card, along with proof
of address; or

(iii) a valid Belizean Driver’s
Licence, accompanied by a
Belizean Birth Certificate or
Belizean Nationality
Certificate.”; and

(b) repealing sub-regulation (3:01) and substituting
the following—

“(3:01) The Fisheries Administrator shall not
grant a Fisherman’s Licence unless
the applicant—

(a) is a Belizean;

(b) is at least 18 years of age;

- (c) provides evidence of residing in Belize for a continuous period of at least six months prior to the date of application;
- (d) provides evidence that the marine product will be for sale only in Belize;
- (e) provides original receipts of sale of marine products in Belize, if the application is for the renewal of a Fisherman's Licence.”.
