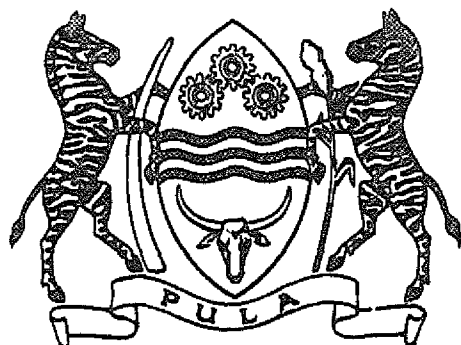

ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

- 1. Citation and Commencement
- 2. Establishment of Subordinate Land Board
- 3. Amendment of Schedule to Cap 32:02 (Sub. Leg.)

IN EXERCISE of the powers conferred on the President by section 19 of the Tribal Land Act, the following Order is hereby made —

- 1. This Order may be cited as the Establishment of Subordinate Land Boards (Amendment) Order, 1992 and shall be deemed to have come into operation on 1st June, 1992. Citation and Commencement
- 2. (1) There is hereby established a Subordinate Land Board to be known as Mogoditshane Subordinate Land Board. Establishment of Subordinate Land Board
 (2) The area of jurisdiction of the Mogoditshane Subordinate Land Board shall be in respect of the following villages, namely, Mogoditshane, Gabane, Mmopane, Nkoyaphiri, Mmokolodi, Kgaphamadi, Tlhape, Gaphatshwe, Dumadumana, Go-nku, Metsimotlhabe, Fikeng, Senamakola, Tloaneng, Phiriabokwete, Tlhwane, Lelotong, Mosusu, Diphiri and Letlhajweng.
- 3. In consequence of the provisions of paragraph 2, the Schedule to the Establishment of Subordinate Land Boards Order is hereby amended in the third column by deleting therefrom — Amendment of Schedule to Cap. 32:02 (Sub. Leg)
 - (a) in relation to Lentswe-le-tau Subordinate Land Board referred to in the second column within the Bakwena Tribal Territory, the following village, namely Mmopane; and
 - (b) in relation to Thamaga Subordinate Land Board referred to in the second column within the Bakwena Tribal Territory, the following villages, namely, Gabane and Mogoditshane.
