PROTECTED PLACES ORDER, 2004

In exercise of the power conferred by subsection (1) of section 5 of the Protected Areas and Protected Places Act, the Minister of Home Affairs hereby makes the following Order —

Citation.

1. This Order may be cited as the Protected Places Order, 2004.

Declaration of protected places.

2. The places specified in the first column of the Schedule hereto which are more particularly described in the plans specified in the second column thereof deposited in the office of the Surveyor-General, are hereby declared to be protected places for the purposes of the Act.

Authority.

3. The authorities respectively specified in the third column of the Schedule hereto are from whom permission to enter the respective protected places are to be received.
