In exercise of the power conferred by section 38(2) of the Wholesome Meat Order, 2011, the Minister of Industry and Primary Resources hereby makes the following Regulations —

Citation and commencement.

1. These Regulations may be cited as the Wholesome Meat (Fees) Regulations, 2011 and shall commence on the same date as the Wholesome Meat Order, 2011.

Fees.

2. The fees specified in the Schedule shall be payable in respect of the services or matters set out opposite thereto.
