STATUTORY RULES AND ORDERS NO. 19 OF 1993

ORDER

MADE by the Minister under section 12(4) of the Beach Control Act (Chap. 42:04).

(Gazetted 27th May, 1993.)

1. This Order may be cited as the –

Short title.

BEACH CONTROL (PROHIBITION) ORDER, 1993.

2. The foreshore or seashore of the bays or beaches listed below and described in the Schedule are prohibited areas –

Prohibited beaches.
Schedule.

- (a) Dubuc Beach;
- (b) Londonderry Bay;
- (c) Mango Hole Bay;
- (d) Massacre Beach;
- (e) Pointe Michel Beach; and
- (f) Tarou Bay.

SCHEDULE

(Section 2).

Dubuc Beach –

From the Geneva River on the West;

Eastward for 1500 metres to Ravine S' Amandes;

South by the Sea, and

North by the Grand Bay - Bagatelle Public Road for 1400 metres from Ravine S'Amandes to a point Westward, where the Grand Bay - Bagatelle Public Road turns inland, and then along the vegetation line of part of the Southern Boundary of the Geneva Estate for 100 metres to the Geneva River.

Londonderry Bay –

From the Melville Hall or Clyde River on the South;

Then Northward for 1200 metres to the Londonderry or Tweed River;

East by the Sea, and

West by the Marigot - Portsmouth Public Road for 750 metres from the Melville Hall or Clyde River, to a point where the Marigot - Portsmouth Public Road turns inland, and then along the vegetation line of part of the Eastern Boundary of the Londonderry Estate for 450 metres, to the Londonderry or Tweed River.

Mango Hole Bay –

From the Crebiche or Mantipo River on the South;

Then Northward for 600 metres to the Melville Hall or Clyde River;

East by the Sea, and

West by the Marigot - Portsmouth Public Road.

Massacre Beach –

From the Boeri River on the South;

Then Northward for 2900 metres to Coubaril;

West by the Sea, and

East by the Mahaut - Massacre Public Road from Coubaril to the Massacre Bypass, then along the Massacre Bypass to the Checkhall River, then along the Western Boundary of the Canefield Airport,

and then along the Western Boundary of the Canefield Industrial Estate to the Boeri River.

Pointe Michel Beach –

From the Loubiere River on the North;

Then Southward for 3200 metres to Anse Bateau at the point where the Loubiere - Soufriere Public Road turns inland;

West by the Sea, and

East by the Loubiere - Soufriere Public Road.

Tarou Bay –

From the Tarou Ravine on the South;

Then Northward for 1700 metres to the Layou River;

West by the Sea, and

East by the Roseau - Layou Public Road for 1500 metres from the Tarou Ravine to a point where the Roseau - Layou Public Road turns inland and then along the vegetation line of part of the Western Boundary of the Hillsborough Estate for 200 metres to the Layou River.
