STATUTORY RULES AND ORDERS No. 30 OF 1973.

REGULATIONS

MADE under Section 15 of the Central Water Authority Act(a).

(Gazetted 27th September, 1973.)

1. These Regulations may be cited as the

**CENTRAL WATER AUTHORITY (AMENDMENT)
REGULATIONS, 1973.**

Short title.

2. In these Regulations the Central Water Authority Regulations 1972 (S.R.O. No. 1 of 1973) are referred to as the Regulations.

Interpretation.

3. Regulation 2 of the Regulations is amended by inserting the following definition therein immediately after the definition of "leakage"

"Nuisance", means an accumulation of water in any ditch, pool, watercourse, drain or gutter which is stagnant or so foul, or in such a state, and is so situated as, in the opinion of the Authority to be so offensive to the public or injurious to health.

4. Regulation 8 of the Regulations is amended by renumbering Regulation 8 as Regulation 8 (1) and by inserting the following as Regulations 8 (2) to 8 (4) respectively—

"(2) Every building provided with a service connection shall to the satisfaction of the Central Water Authority, be provided with drains properly laid to a suitable outfall and capable of disposing of waste or any surface water without creating a nuisance.

(3) Upon application by a customer for water service it shall be the duty of the Authority to ensure that proper arrangements for the disposal of waste or any surface water exists before the connection is made.

(4) Notwithstanding that the water rate chargeable in respect of any such premises shall have been paid, the Authority may cut off the supply to any premises in respect of which the owner or occupier has had at least two months notice calling for the abatement of a nuisance caused by waste or surface water, and has failed to do so."
