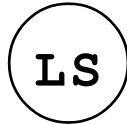


**COMMONWEALTH OF DOMINICA**

ACT NO. 4 OF 2021.

*I assent***CHARLES A. SAVARIN**  
*President*30<sup>th</sup> April, 2021**ACT TO AMEND THE FORESTRY AND WILDLIFE  
ACT CHAP. 60:02.***(Gazetted 4<sup>th</sup> May, 2021.)*BE IT ENACTED by the Parliament of the Commonwealth  
of Dominica as follows:

1. This Act may be cited as the -

**FORESTRY AND WILDLIFE  
(AMENDMENT) ACT, 2021.**

Short title.

Interpretation.  
Ch. 60:02.

**2.** In this Act the Forestry and Wildlife Act is referred to as “the Act”.

Amendment of  
section 2 of the Act.

**3.** Section 2 of the Act is amended by inserting the following new definition immediately after the definition of “director”:

““export” means -

- (a) to take or cause to be taken outside the territorial waters of Dominica;
- (b) to load or cause to be loaded on a vessel or an aircraft;”.

Repeal and replacement  
of section 32 of the Act.

**4.** Section 32 of the Act is repealed and replaced as follows:

“Exporting of  
wildlife.

**32.** No person shall export any live or dead wildlife or parts thereof cooked, frozen or processed, except with a permit issued by the Director in Form 5, and in accordance with conditions specified in the permit.”.

Insertion of new  
section 60A.

**5.** The Act is amended by inserting the following new section 60A immediately after section 60:

“Penalties for  
contravening  
sections 32, 33  
and the Ninth  
Schedule.

**60A.** A person who contravenes –

- (a) section 32 is liable on summary conviction to a fine of five thousand dollars;
- (b) section 33 is liable on summary conviction to a fine of two thousand five hundred dollars;
- (c) regulation 2(c) of the Ninth Schedule is liable on summary conviction to a fine of seven thousand five hundred dollars.”.

6. Section 63 of the Act is repealed and replaced by the following:

Repeal and replacement of section 63.

“Penalty for contravening section 62.

63. A person who contravenes –

- (a) section 62 (a) is liable on summary conviction to a fine of ten thousand dollars;
- (b) section 62 (b) is liable on summary conviction to a fine of twenty-five thousand dollars;
- (c) section 62 (c) or (d) is liable on summary conviction to a fine of five thousand dollars,

and to imprisonment for three years.”.

7. The Seventh Schedule to the Act is amended by inserting the following Form 5 immediately after Form 4:
