Short Title</u> This proclamation may be cited as the “Geothermal Resource Development (Amendment) Proclamation No. 1204/2020”. <u>2.Amendment</u> The Geothermal Resource Development Proclamation No. 981/2016 is hereby amended as follows: 1/ The title of part five of the proclamation is deleted and replaced by the following new title: “administration, compensation, exemption from custom duties and taxes, income tax, license fees

2/ The title of Article 44 of the Proclamation is deleted and replaced by the following new title:

“Exemption from Customs Duties and Taxes and Income Tax paid by the Licensee”

3/ The following new sub-article (3) is added following sub Article (2) of Article 44 of the Proclamation:

“3/The tax rate applicable on any Licensee engaged in developing geothermal energy for sale shall be the rate provided for mining and petroleum operations under chapter four of the Federal Income Tax Proclamation No. 979/2016.”

4/ Sub article (2) of Article 46 of the Proclamation is deleted and replaced by the following new sub article (2):

“2/ In the event that agreement cannot be reached between the licensing authority and a licensee through negotiation within ninety (90) days, the case shall be referred to an arbitration tribunal which will give a binding and final decision.”

5/ Sub article (3) of Article 46 of the proclamation is deleted.

6/ The following new sub-article (4) is added after sub article (3) of Article 48 of the Proclamation is added:

“4/ Provisions of this Proclamation which are inconsistent with agreements that were under negotiation on the basis of a geothermal exploration license issued in accordance with the Mining Operations Proclamation No. 678/2010 (as amended) prior to the coming into force of this proclamation to engage in
