THE FOOD AND DRUGS (EUROPEAN CONSUNTTIES) (WINE) ORDER ROTHER

THE STATES BOARD OF HIALTH, in exercise of the powers conferred of it by sections four, seven, forty-seven and forty-seven A of the Food and Drugs (Guernsey) Law, 1970(a), as amended (b), and of nitother powers enabling it in that behalf hereby orders:
Interpretation

"the Chief Revenue Officer" means the Chief Revenue
Officer for the time being appointed by the States
Civil Service Board and includes any States
Revenue Officer acting by or under the authority
of the Chief Revenue Officer;
"Community provision" means any provision of the
regulations of the European Committee referred
to in the Schedule to this Order and includes
any provision of any Community instrument
whereby any of those regulations are replaced
or amended.
"the Law" means the Food and Drugs (Guernsey) Law,

"States Revenue Officer" means a person appointed to act as such by the States Board of Administration

- (2) The Interpretation (Gnermacy) Law, 1948(c) shall apply to the interpretation of this Order as it applies the interpretation of a Guernsey enactment.
- (3) Except in so far as the context otherwise requires, the reference in this Order to any exactment shall be construct as a reference to that enactment as amended, repealed and replaced, extended or applied by or under any other exactment.

 Enforcement
- 2. It shall be the duty of the Chief Revenue Officer to secure the enforcement and execution of the Community provisions.

 Officeres
- 5. If any person contravence or fails to comply with any Community provision he shall be suilty of an effence and shall be liable on conviction to a fine not exceeding one hundred pounds and, in the case of a continuing offence, to a further fine not exceeding five pounds for each day during which the offence occurs after conviction.

Application of various sections of the Law

4. Section forty (which relates to a contravention due to some person other than the person charged) and section forty-one (which relates to the conditions under which a warranty may be pleaded as a defence) of the Law shall apply for the purposes of this Order as if references therein to proceedings taken or brought under the Law included references to proceedings taken or brought under this Order.

Extent

5. This Order shall have effect in the Islands of Guornsey, Alderney, Herm and Jethou.

Citation and commencement

6.(1) This Order may be cited as the Food and Druge (Muropean

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport)

- 1. This Order, which has effect throughout the Islands of Guernsey, Alderney, Herm and Jethou implements the "Community provisions" concerned with the production and marketing of wine.
- 2. The Community provisions are the provisions of the regulations of the European Economic Community set out in the Schedule to the Order and of any Community instrument whereby any of the scheduled regulations is replaced or amended. Copies of the Community provisions may be obtained from the Chief Revenue Officer.
- 3. The Chief Revenue Officer is responsible for the enforcement and execution of the Community provisions.
 (Section 2).
- 4. It is an offence for any person to contravene or to fail to comply with any Community provision. (Section 3).
- 5. Specified defences under the Food and Drugs (Guernsey)
 Law, 1970, as amended, are available to a person
 charged with an offence under the Order. (Section 4).
- 6. The Order is of particular concern to sellers and bottlers of wine and other persons in the wine trade.
- 7. Wine imported in bulk into the Bailiwick must be accompanied by a document (VA form, etc.) giving details of the wine and of its quality. Such a document is also required in the case of wine imported in bottles not having approved closures (corks, stoppers, capsules, etc.) Persons bottling wine imported in bulk are

required to use approved closures bearing the name and address or the registered code number of the bottler. Labels must comply with the Community provisions. Misleading descriptions of wine are not permitted.
