HAVING SEEN Village Council decisions, endorsed by Village General Meetings, submitted by the below listed villages and requesting that a District Council be established;


HAVING VERIFIED that the other requirements set out in Section 35(1) and (2) of the Amerindian Act 2006, Act No. 6 of 2006 have been satisfied;

AND IN EXERCISE of the power conferred on the Minister by Section 35 of the Amerindian Act 2006, Act No. 6 of 2006, I hereby make the following order:-

1. This Order may be cited as the **SOUTH RUPUNUNI DISTRICT COUNCIL** Order 2017
2. The **SOUTH RUPUNUNI DISTRICT COUNCIL** shall be comprised of the Toshao and one Councillor from the following villages,¹ including where they so decide their satellite villages:²

 12. Sawariwau (*Sawarowaoro*),
 13. Shea (*Shii*),
 14. Shulinab (*Shorinab*)
