Transport Permit

The Guyana Wildlife Conservation and Management Commission (GWCMC) will issue trappers and middlemen transport permits along with their licenses. Information to be included on the permit includes:

- name of the trapper/hunter/middleman,
- location in which animals were trapped/hunted,
- name of the persons transporting the wildlife,
- type of transportation used to transport wildlife (e.g., bus, car, boat, van, etc.),
- intended destination,
- a list of species that are being transported and the state they are in (dead/alive; skin/parts),
- amount of each species being transported,
- sex of the animals (where possible),
- whether young or adult, and
- record of any deaths.

Transport permits will only be valid for a certain period of time.

These permits will help the Commission in collecting accurate data about the wildlife that is being utilised across Guyana. It will reflect who is using wildlife, where wildlife is being used, how it is being used and more importantly, it will allow the Commission to record how much wildlife is being used. This will put the Commission in a better position as it relates to managing our wildlife and to prevent over-exploitation or illegal trade.

Checkpoints

Wildlife users who will be transporting wildlife (whether live animals or meat) will be required to stop at various checkpoints across the country to have their transport permits endorsed. At these checkpoints, transporters of wildlife will be required to present their transport permit and declare the wildlife in their possession to the officials there. Officers will check the documents presented to verify that the information presented is correct and corresponds with the wildlife being transported. Officers will also be checking to ensure that closed seasons for hunting and trapping are respected, and that hunting and trapping are being done in allowed areas.

The Commission is excited about this new process and our staff are all committed to ensuring it works in an effective manner so that wildlife users can continue to benefit from our wildlife resources while ensuring stable populations are maintained.

We take this opportunity to thank our sister agencies who will be supporting us in this venture and look forward to serving our various stakeholders through the domestic licensing system. Through our collective effort, we will secure the future of our wildlife.

Local Wildlife Trade Requirements

To obtain a licence for any category of wildlife use, applicants will be required to submit:

- A filled Application Form
- National Identification Card or Passport
- Two (2) recent Passport size photos
- TIN Certificate
- Firearm License
- Show proof of having adequate housing for trapped wildlife (for trappers and middlemen)
- Food Handling Certificate (Restaurants, cook-shops, rum-shops/bars)
- Pay an Application Processing Fee of \$4,000
- Produce any other documents deemed necessary by the Commission.

Applications are vetted by the Commission and once approved, the applicant is required to pay the corresponding fee.

N.B. Indigenous Village Councils who have members trading commercially will have to apply for a Village licence

General Terms and Conditions of Licences

The GWCMC agreed on the following general terms and conditions for domestic licences:

- Licences are not transferable;
- No harvesting permitted in protected areas;
- No harvesting is permitted on titled or private lands without the written permission of the person legally authorised to grant such permission;
- All firearms used in the process of harvesting wildlife must be licensed;
- Licensee must adhere to all local laws associated with the activity for which they are licensed;
- This licence does not supercede, but is issued in conjunction with Regulations set out by all other associated regulatory bodies;
- Licensees must adhere to all terms and conditions set out in the Annex issued together with this licence;

j. No harvesting is allowed during the closed season stipulated by the Guyana Wildlife Conservation and Management Commission.

Terms and Conditions for Holders of a Wildlife Trapping Licence

The terms and conditions that follow are to be upheld by Trappers of wildlife. In this context, a trapper is defined as “any individual who harvests wildlife species from the natural environment for personal use or for sale to anyone who is licensed to use wildlife.”

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Be in possession of their licence when trapping and transporting wildlife species.
2. Ensure all legal requirements are met when transporting wildlife.
3. Adhere to the specifications for transporting and holding live animals as prescribed by the GWCMC.
4. Ensure that animals are held and transported in a manner that minimises the risk of injury, damage to health, cruel treatment and suffering.
5. Ensure that the removal permit is accurately completed and verified at the checkpoints identified by the GWCMC.
6. Maintain accurate records in a format specified by the GWCMC.
7. Observe all health and safety practices including, but not limited to, the possession of a first aid kit and knowledge of how to utilize same.
8. Ensure that animals are trapped, handled and transported in a manner that minimises the risk of injury, damage to health, cruel treatment and suffering.
9. Comply with all laws, regulations and guidelines of the GWCMC.
10. Not trap venomous snakes unless written approval is provided by the GWCMC.
11. Pay royalties on every specimen harvested (see Royalty schedule on pg.)

Failure on the part of the licence-holder to adhere to the terms and conditions of this

licence may result in revocation of the licence and/or application of the penalties as prescribed in the Wildlife Conservation and Management Act and its regulations.

Terms and Conditions for Holders of Wildlife Collecting Licences, Class 1- Middlemen

The terms and conditions that follow are to be upheld by any person who collects, gathers, harvests, buys and sells wildlife in Guyana.

The licence-holder shall comply with the terms and conditions laid out in this licence.

The licence-holder shall:

1. Be in possession of the licence when transporting wildlife.
2. Ensure all legal requirements are met when transporting wildlife.
3. Adhere to the specifications for transporting and holding live animals as prescribed by the GWCMC.
4. Ensure that the removal permit is accurately completed and verified at the checkpoints identified by the GWCMC.
5. Ensure that animals are held and transported in a manner that minimises the risk of injury, damage to health, cruel treatment and suffering.
6. Maintain accurate records in a format specified by the GWCMC.
7. Observe all health and safety practices including, but not limited to the possession of a first aid kit and knowledge of how to utilise same.
8. Comply with all laws, regulations and guidelines of the GWCMC.

Failure on the part of the licence-holder to adhere to the terms and conditions of this licence may result in revocation of the licence and/or application of the penalties as prescribed in the Wildlife Conservation and Management Act and its Regulations.

Guidelines for Trappers and Holders of Wildlife

- Due attention must be paid to the diet and nutritional requirements of animals being transported;
- During transport:
 - ⇒ Animals must not be over-crowded in containers and cages;
 - ⇒ Animals must be provided with adequate food and water;
 - ⇒ Animals must be kept in adequately ventilated cages;
 - ⇒ Predators and prey should not be transported together or in proximity to each other as this would cause undue stress to these species;
 - ⇒ Nocturnal animals (animals active at night) must be transported in containers with

- Sick animals must be isolated and reasonably cared for;
- Visibly pregnant animals and animals with young shall only be transported in exceptional circumstances;
- For social species, where polygamy exists and homegroups consist of more than two individuals, it is strongly recommended that members be taken from the sex present in greater numbers;
- It is expected that a small percentage of mortalities may occur. Deaths must be accurately recorded on the register and removal permit. Dead animals must be disposed of in an acceptable manner. This includes:
 - Burial in an area away from a water supply; or
 - Incineration where it is safe to do so.
- Unusual levels of mortalities (deaths) must be reported immediately to personnel of the Guyana Livestock Development Authority and GWCMC.

Terms and Conditions for Holders of Wildlife Commercial Licences, Plant Shop

The terms and conditions that follow are to be upheld by any person who engages in the sale of plants at a single place of business.

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Comply with all legal requirements under the Wildlife Conservation and Management Act 2016, the Plant Protection Act 2011 and any other law when importing plant species.
2. Dispose of specimens in a manner approved by the GWCMC.

Failure on the part of the licence-holder to adhere to the terms and conditions of this licence may result in the revocation of this licence and/or application of the penalties prescribed in the Wildlife Conservation and Management Act 2016 and its Regulations.

Terms and Conditions for Vendors of Raw Wildmeat

The terms and conditions that follow are to be upheld by any person who engages in the sale of wildmeat at a single place of business.

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Maintain accurate records of acquisitions and sales in the format prescribed by the GWCMC.
2. Purchase meat from hunters/collectors/trappers who are the holders of valid licences issued by the GWCMC.
3. Submit accurately completed records as prescribed by the GWCMC by the stipulated timeline.
4. Adhere to the local sanitary standards as stipulated by the relevant authorities and by the GWCMC for the transport, storage and display of wildmeat for human consumption.
5. Ensure the premises on which wildmeat is handled, processed and stored is approved by the relevant authority.

Failure on the part of the licence-holder to adhere to the terms and conditions of this licence may result in the revocation of the licence and/or application of the penalties prescribed in the Wildlife Conservation and Management Act and its Regulations.

Terms and Conditions for Sellers of Live Animals

The terms and conditions that follow are to be upheld by any person who engages in the sale of live animals at a single place of business.

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Acquire animals from licensed wildlife trappers or dealers.
2. Obtain import permits from the GWCMC where non-native species are to be imported.
3. Maintain accurate records of acquisitions and sales in the format prescribed by the GWCMC.
4. Submit accurately completed records as prescribed by the GWCMC by the stipulated timeline.
5. Be the holder of a captive wildlife licence.
6. Ensure that the animals are held in a manner that minimizes the risk of injury, damage to health, cruel treatment and suffering.
7. Excess animals which are not sold, must be disposed of in a manner approved by the GWCMC.

Failure on the part of the licence-holder to adhere to the terms and conditions of this licence may result in the revocation of this licence and/or application of the penalties

Terms and Conditions for Vendors of Cooked Wildmeat

The terms and conditions that follow are to be upheld by any person who engages in the sale of cooked wild meat (restaurants, cook-shops, rum-shops/bars) at a single place of business.

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Possess a food handling certificate issued by the relevant authority in the region where the sale takes place.
2. Submit to the GWCMC all records of sales and purchases and where applicable, the wildlife removal permit. All records must be maintained in a manner prescribed by the GWCMC.
3. Adhere to local sanitary standards as stipulated by the relevant authorities and by the GWCMC for the transport, storage and display of wildmeat for human consumption.
4. Purchase meat from hunters/collectors/trappers who are the holders of valid licences issued by the GWCMC.
5. Ensure that the premises on which wildmeat is handled, processed, stored and prepared for consumption is approved by the relevant authority.

Failure on the part of the licence holder to adhere to the terms and conditions of this licence may result in revocation of the licence and/or application of the penalties prescribed in the Wildlife Conservation and Management Act and its Regulations.

Terms and Conditions for Holders of Wildlife Recreational Licences

The terms and conditions that follow are to be upheld by any wildlife recreational licensee. A wildlife recreational licensee is defined as “an individual or group of persons who hunt for personal pleasure and do not engage in commerce.”

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Hunt in areas approved by the GWCMC. Hunting shall not take place in Protected Areas, on titled lands or private properties without written permission.
2. Be in possession of this licence when the hunting activity is taking place.
3. Use only weapons approved by the GWCMC. Firearms used by the licence –holder

must be licensed.

4. Follow all prescribed safety rules and conditions on the firearm licence.
5. Adhere to the closed seasons published by GWCMC.
6. Not hunt the following:
 - Protected species and species of conservation concern i.e. species listed in the First Schedules of the Wildlife Conservation and Management Act and the Wildlife Conservation, Management and Sustainable Use Regulations;
 - Pregnant animals; and
 - Young animals.
7. Harvest once annually in each of the approved harvest areas and according to the quotas set by the GWCMC.
8. Adhere to the bag limit determined by the GWCMC.
9. Utilise tags issued by the GWCMC to identify all specimens harvested. Tags must be visible and readable at all times. Tags are not to be reused or redistributed without the written approval of GWCMC.
10. Maintain accurate records in a format specified by GWCMC.
11. Ensure that the removal permit is accurately completed and verified at the checkpoints identified by the GWCMC.
12. Ensure that there is no undue suffering to the animals being hunted.
13. Employ best practices in hunting including guidelines provided by the GWCMC.

Terms and Conditions for Holders of Captive Wildlife Licences

The terms and conditions that follow apply to persons who are holding wildlife in a facility for commercial purposes.

The licence-holder shall comply with the terms and conditions laid out in this licence.

The licence-holder shall:

1. Isolate animals brought into the facility for a period of time prescribed by the GWCMC.
2. Maintain accurate records of the species in the facility.
3. Submit accurately completed records as prescribed by the GWCMC by the stipulated timeline.
4. Facilitate monthly inspections of the facility by the GWCMC.

Failure on the part of the licence-holder to adhere to the terms and conditions of this licence may result in revocation of the licence and/or application of the penalties as prescribed in the Wildlife Conservation and Management Act and its regulations.

Guidelines for Holders of Captive Wildlife Licences

The licence-holder must provide the necessary care for the animals. Attention must be paid to the following:

- Due attention must be paid to the diet and nutritional requirements of animals that form part of the collection;
- Animals must not be overcrowded in enclosures;
- Animals must be kept in adequately ventilated enclosures;
- Predators and prey should not be housed together or in proximity to each other as this would cause undue stress to the species;
- Where appropriate (and especially for nocturnal animals), provide hide-boxes for the animals;
- Sick animals must be isolated and reasonably cared for. Where necessary, a Veterinarian must attend to the animal;
- An enrichment plan must be developed for each animal;
- It is expected that a small percentage of mortalities may occur. Deaths must be accurately recorded on the register. Dead animals must be disposed of in an acceptable manner. This includes 1) burial in an area away from a water supply; or 2) incineration where it is safe to do so.
- Unusual levels of deaths must be reported immediately to personnel of the Guyana Livestock Development Authority or the GWCMC.

Terms and Conditions for Holders of a Special Wildlife Licence, Class 1- Scientific Research

The terms and conditions that follow are to be upheld by any person or institution who hunts, confines or keeps in captivity any wildlife for scientific research.

The licence holder shall comply with the terms and conditions of this licence. The licence-holder shall:

1. Have this licence in his/her possession during collection of specimens. If the licence holder is a research facility, a copy of the licence must be displayed at the facility.
2. Fulfill the requirements of other agencies/ institutions when conducting research on wild species of flora and fauna and, if necessary, exporting specimens of the same.
3. Share data collected with the GWCMC before leaving Guyana and furnish the GWCMC with a final report of their findings upon completion of the same.
4. Not conduct research on Indigenous lands without the express approval of both the Ministry of Indigenous Peoples' Affairs and the Village Council of the area of interest.
5. Not remove protected species from the natural environment without the written approval of the GWCMC.

Failure on the part of the licence holder to adhere to the terms and conditions of this licence may result in the revocation of the licence and/or application of the penalties prescribed in the Wildlife Conservation and Management Act and its Regulations.

Terms and Conditions for Holders of a Special Wildlife Licence, Class 2 – National Collection Licence and Class 3- Private Collection Licence

The terms and conditions that follow are to be upheld by any person/institution who hunts, keeps or confines in captivity any wildlife for a collection for exhibition/display.

The licence-holder shall comply with the terms and conditions laid out in this licence. The licence-holder shall:

1. Display a copy of the licence at the collection site.
2. Collect species only with prior approval of the GWCMC.
3. Comply with all laws, regulations and guidelines of the GWCMC.
4. Where live animals are part of the collection, adhere to the specifications for holding live animals as prescribed by the GWCMC.
5. Ensure strict hygienic practices are observed at all times.
6. Maintain accurate records in a format specified by the GWCMC.
7. Have appropriate housing for each species held at the premises.
8. Ensure that the animals are cared for in a manner that minimizes the risk of injury, damage to health, cruel treatment and suffering.
9. Dispose of dead animals in a manner deemed acceptable by the GWCMC.

Failure on the part of the licence holder to adhere to the terms and conditions of this licence may result in the revocation of the licence and/or application of the penalties

prescribed in the Wildlife Conservation and Management Act and its regulations.

Guidelines for Holders of Special Wildlife Licences

Where live animals are being held, the licence-holder must provide the necessary care for the animals. Attention must be paid to the following:

- The diet and nutritional requirements of animals that form part of the collection;
- Animals must not be overcrowded in enclosures;
- Animals must be kept in adequately ventilated enclosures;
- Predators and prey should not be housed together or in proximity to each other as this would cause undue stress to the species;
- Where appropriate (and especially for nocturnal animals), provide hide-boxes for the animals;
- Sick animals must be isolated and reasonably cared for. Where necessary, a Veterinarian must attend to the animal;
- An enrichment plan must be developed for each animal;
- It is expected that a small percentage of mortalities may occur. Deaths must be accurately recorded on the register. Dead animals must be disposed of in an acceptable manner. This includes 1) burial in an area away from a water supply; or 2) incineration where it is safe to do so.
- Unusual levels of deaths must be reported immediately to personnel of the Guyana Livestock Development Authority or the GWCMC.
