**THE ESTABLISHMENT OF A PERMANENT WORKING COMMITTEE FOR  
BIOLOGICAL NATURAL RESOURCES AND THEIR ECOSYSTEM**

**THE MINISTER OF FORESTRY AND  
THE STATE MINISTER OF ENVIRONMENTAL AFFAIRS**

- Considering** :
- a. that to improve coordination in the conservation of biological natural resources and their ecosystem including the preparation of a concept for the development of sustainable utilization of biological diversity and the dissemination of information at home and abroad, it is deemed necessary to establish a Permanent Working Committee for the Conservation of Biological Natural Resources (PANJATAP KSDAH);
  - b. that it is deemed necessary to stipulate the establishment of PANJATAP KSDAH as referred to in point a in a Joint Decree of the Minister of Forestry and the State Minister of Environmental Affairs.

**HAS DECIDED :**

**To stipulate** :

**FIRSTLY** :

The establishment of a Permanent Working Committee for the Conservation of Biological Natural Resources and their Ecosystem (PANJATAP KSDAH) in the framework of cooperation between the Ministry of Forestry and the Office of the State Minister of Environmental Affairs with the following membership composition :

Ist Chairman : Director General of Forest Protection and Nature Conservation.

IInd Chairman : 3rd Assistant to the State Minister of Environmental Affairs in Implementation Coordination.

- Ist Secretary** : Director of Programme Development, Directorate General of Forest Protection and Nature Conservation.
- IInd Secretary** : Assistant to 3rd Assistant to the State Minister of Environmental Affairs in charge of International Institutions.
- Members** :
1. Director of Forest Protection, Directorate General of Forest Protection and Nature Conservation.
  2. Director of the Development of Areas for Nature Conservation, Directorate General of Forest Conservation and Nature Conservation.
  3. Director of the Development of Natural Reserves and the Conservation of Flora and Fauna, Directorate General of Forest protection and Nature Conservation.
  4. Director of Forest Use System, Directorate General of INTAG.
  5. Director of Forest Management Preparation, Director General of Forest protection and Nature Conservation.
  6. Head of the centre for Research and Development of Forest and Nature Conservation.
  7. Head of the Bureau of Legal Affairs and Organization, Secretariat General of the Ministry of Forestry.

  9. Head of the Bureau of Public Relations, Secretariat General of the Ministry of Forestry.
  10. Assistant to 1st Assistant to the State Minister of Environmental Affairs in charge of Environmental Ordering and Utilization.
  11. Assistant to 1st Assistant to the State Minister of Environmental Conservation and Development.
  12. Assistant to 2nd Assistant to the State Minister in charge of the Planning of Sectoral Integration Policy Implementation.
  13. Assistant to 3rd Assistant to the State Minister in charge of Governmental Institutions.

14. Assistant to 4th Assistant to the State Minister of Environmental Affairs in charge of the development of Environmental Control System and Management.
15. Head of the Bureau of Foreign Cooperation of the Office of the State Minister of Environmental Affairs.
16. Director of the Development of AMDAL (the Analysis of Environmental Impact) Control, 1st Deputy of Environmental Impact Control Agency.

**SECONDLY :**

The tasks of PANJATAP KSDAH are :

- a. formulating policy concepts and coordinating, monitoring and evaluating the implementation of policies on the management of Natural Reserves, Areas for the Conservation of Nature, Hunting Parks and protected Forests.
- b. formulating policy concepts and coordinating, monitoring and evaluating the implementation of policies on the preservation and utilization of the diversity of biological natural resources and their ecosystem in a sustainable manner.
- c. formulating policy concepts and coordinating, monitoring and evaluating the implementation of policies on the management of life buffer system protection zones.
- d. formulating policy concepts and coordinating, monitoring and evaluating the implementation of policies on managing or deterring global issues on the utilization of forest/forest produce in a sustainable manner.
- e. formulating policy concepts and coordinating, monitoring and evaluating the implementation of policies on community participation in the conservation of biological natural resources and their ecosystem.

**THIRDLY**

PANJATAP KSDAH shall report the implementation of its tasks periodically and shall be responsible to the Minister of Forestry and the State Minister of Environmental Affairs.

**FOURTHLY**

To expedite its tasks the Chairman of PANJATAP KSDAH shall be authorized :

- a. to stipulate the working system of PANJATAP KSDAH;
- b. to set up working groups to deal with the tasks as referred to in the SECOND dictum of this Joint decree;

c to request other agencies to be represented as members of working groups when it is deemed necessary.

**FIFTHLY :**

All costs which arise as a result of the issuance of this Joint Decree shall be borne by the budgets of the Ministry of Forestry and the Office of the State Minister of Environmental Affairs.

**SIXTHLY :**

This Joint Decree shall be effective as from the date of stipulation.
