# DELAY ON NEW LECENSE ISSUANCE AND PERFECTION OF GOVERNANCE OF PRIMARY NATURAL FOREST AND PEAT LANDS

# (Instruction of President of Republic of Indonesia Number 10 Year 2011, 20 May 2011)

THE PRESIDENT OF REPUBLIC OF INDONESIA.

In order to balance and to synchronize the development of economy, social, culture, and environment as well as effort to decrease Greenhouse Gas Emission, which is carried out through emission reduction from deforestation and forest degradation, hereby instruct:

#### To:

- 1. The Minister of Forestry;
- 2. The Minister of Domestic Affairs;
- 3. The Minister of Environment;
- The Head of Presidential Working Unit for Development Supervision and Control;
- 5. The Head of National Land Agency;
- The Chairman of National Spatial Order Coordination Agency;
- The Chairman of National Survey and Mapping Coordination Agency;
- The Head of REDD+ Institutional Establishment
   Preparation Task Force or Head of the institution formed to carry out special duties in REDD+ field;
- 9. The Governors;
- 10. The Regents/Mayors;

For:

#### FIRST:

To take necessary steps accordingly to respective duties, functions, and authorities to support delay on new license issuance for primary natural forests and peat lands within conservation forest, protection forest, production forest (limited production forest, regular/permanent production forest, conversable production forest) and other areas of usage as stated on Indicative Map of New License Delay as the Attachment of Presidential Instruction.

# SECOND:

Delay on new license issuance as meant in FIRST Dictum, applies on the use of primary natural forests and peat lands area, with exception granted to:

- a. Application that has been granted principle approval from the Minister of Forestry;
- b. Implementation of national development with vital nature, they are: geothermal, oil and natural gas, electricity, land for paddy and sugarcane;
- c. Extension of existent license of forest use and/or forest area use as long as the license of the business field is still valid; and
- d. Ecosystem restoration.

#### THIRD: Especially to:

#### 1. The Minister of Forestry:

- a. To apply delay upon the issuance of new license for primary natural forests and peat lands within conservation forest, protection forest, production forest (limited production forest, regular/permanent production forest, conversable production forest) based on New License Delay Indicative Map.
- to perfect the governance policy for borrowuse license and business license for wood forest production use of natural forest.
- c. To increase effectiveness of critical land management by observing the good governance policy of forests and peat lands, among others, through ecosystem restoration.
- d. to perform revision upon New License Delay Indicative Map at forest area once every 6 (six) months.
- e. To stipulate New License Delay Indicative Map of primary natural forests and peat lands at revised forest area.

#### 2. The Minister of Environment:

To carry out efforts for emission reduction from forests and peat lands through governance improvement in business activities suggested for forests and peat lands decided in New License Delay Indicative Map through environmental incense.

3. The Minister of Domestic Affairs:

To perform guidance and supervision upon Governor and Regent/Mayor in the implementation of this Instruction of President.

4. Head of National Land Agency:

To perform delay upon the issuance of rights upon land, such as rights to cultivate, rights to use at other usage areal based on New License Delay Indicative Map.

The Chairman of National Spatial Order Coordination Agency:

To perform consolidation acceleration of New License Delay Indicative Map into the revision of area spatial map as part of governance ordering of land use through cooperation with Governor, Regent/Mayor, and the Head of hcDD+ Institutional Establishment Preparation Task Force or Head of the institution formed to carry out special duties in REDD+ field.

The Chairman of National Survey and Mapping Coordination Agency:

To perform renewal of forests and peat lands covers map accordingly to New License Delay Indicative Map in the forest area and other usage area once every 6 (six) months through cooperation with the Minister of Forestry, the Head of National Land Agency, and the Head of REDD+ Institutional Establishment Preparation Task Force or Head of the institution formed to carry out special duties in REDD+ field.

7. The Governors:

To perform delay of new recommendation and location license issuance for forest areas and peat lands as well as other usage areal based on New License Delay Indicative Map.

8. The Regents/Mayors:

To perform delay of new recommendation and

location license issuance for forest areas and peat lands as well as other usage areal based on New License Delay Indicative Map.

#### FDURTH:

New License Delay Indicative Map in the areal of other usage as the result of renewal as intended in the THIRD Dictum number 6 stipulated by the Minister of Forestry.

#### FIFTH:

delay on new license issuance, recommendation, location permit issuance as intended in the THIRD Dictum is implemented for 2 (two) year since the issuance of this Instruction of President.

#### SIXTH:

The implementation of this Instruction of President is reported by the Minister of Forestry to the President every 6 (six) months or anytime necessary.

# SEVENTH:

The Head of Presidential Working Unit for Development Supervision and Control and/or Head of

REDD+ Institutional Establishment Preparation Task Force or the Head of the institution formed to carry out special duties in REDD+ field perform supervision of the implementation of this Instruction of President and report the result to the President.

#### EIGH TH:

To implement this Instruction of President with full responsibility.

This Instruction of President starts to take effect since the issuance date.
