GOVERNMENT REGULATIONS

MEASUREMENT AND TESTING OF FOREST PRODUCT

(The Regulation of Minister of Forestry of RI Number P. 45/Menhut-II/2011, 24 May 2011)

BY THE GRACE OF ONE AND ALMIGHTY GOD

THE MINISTER OF FORESTRY OF

REPUBLIC OF INDONESIA,

Considering:

- a. that based on Article 117 paragraph (2) and paragraph (3), Government Regulation Number 6 Year 2007 concerning Forest Arrangement and Preparation of Forest Management Plan as well as Forest Utilization, as has been amended with Government Regulation Number 3 Year 2008, authority officers carry out decision on type, measurement of volume/weight, and/or total calculation and can perform test upon all forest products from state forest;
- b. that based on Article 118 paragraph (1), Government Regulation Number 6 Year 2007 concerning Forest Arrangement and Preparation of Forest Management Plan as well as Forest Utilization, as has been amended with Government Regulation Number 3 Year 2008, upon all forest products from private forest, decision on type, measurement of volume/weight, and/or total calculation as well as statement letter of private forest product origin;
- c. that based on Article 120 paragraph (4), Government Regulation Number 6 Year 2007 concern-

- ing Forest Arrangement and Preparation of Forest Management Plan as well as Forest Utilization, as has been amended with Government Regulation Number 3 Year 2008, extending laws concerning the arrangement for measurement and testing of forest product are regulated with Minister Regulation:
- d. that in relation with those aforementioned, it is necessary to stipulate Regulation of Minister of Forestry concerning Measurement and Testing of Forest Product;

In view of:

Government Regulation Number 6 Year 2007 concerning Forest Arrangement and Preparation of Forest Management Plan as well as Forest Utilization (State Gazette of Republic of Indonesia Year 2007 Number 22, Supplementary State Gazette of Republic of Indonesia Number 4696), which has been amended with Government Regulation Number 3 Year 2008 (State Gazette of Republic of Indonesia Year 2008 Number 16, Supplementary State Gazette of Republic of Indonesia Number 4814);
- President Regulation Number 47 Year 2009 concerning Formation and Organization of State Ministry of Republic of Indonesia;
- President Regulation Number 24 Year 2010 concerning Positions, Duties, And Functions of State Ministry As Well As The Order of Organization, Duties, and Functions of Echelon I of State Ministry;
- 5. Presidential Decree Number 84/P Year 2009 concerning Formation of United Indonesia Cabinet II:

DECIDED:

To stipulate:

REGULATION OF THE MINISTER OF FORESTRY CONCERNING MEASUREMENT AND TESTING OF FOREST PRODUCT.

CHAPTER I GENERAL PROVISIONS

Article 1

In this Regulation there are definitions as follows:

- Forest products are living things, non-living things and their derivatives as well as service derived from forest.
- State forest is forest located on the ground that is not burdened with rights upon land.
- Private forest is forest located on the ground that is burdened with rights upon land.

GOVERNMENT REGULATIONS

- Measurement of forest product is activity to decide total, type, volume/weight of forest product.
- Testing of forest product is activity to decide total, type, volume/weight and quality of forest product.
- 6. Authority officer is the Technical Manpower of Sustainable Production Forest Management (GA-NISPHPL) or Supervisor of Technical Manpower of Sustainable Production Forest Management (WAS-GANISPHPL) as qualified personnel and appointed by the authority official.
- 7. GANISPHPL is Officer of company, the license holder of sustainable production forest management, who has competency in sustainable production forest management in the field of forest product testing accordingly to the qualification that is Deep Forest Roundwood Testing (PKB-R), Teak Roundwood Testing (PKB-J), Forest Sawn Wood Testing (PKG-R), Teak Sawn Wood Testing (PKG-J), Plywood Testing (PKL), Chip Testing (PChip), Trunk Group Testing (JIPOKTANG), Latex Group Testing (JIPOKTAH), Oil Group Testing (JIPOKMIN), Resin Group Testing (JIPOKSIN), Wood Charcoal Testing (PAK), and Bark Group Testing (JIPOKLIT), appointed and dismissed by the Head of Hall on behalf of Director General.
- 8. WAS-GANISPHPL is forestry Officer who has competency in supervision and inspection of sustainable production forest management in the field of forest product testing accordingly to the qualification that is Deep Forest Roundwood Test-

- ing (PKB-R), Teak Roundwood Testing (PKB-J), Forest Sawn Wood Testing (PKG-R), Teak Sawn Wood Testing (PKG-J), Plywood Testing (PKL), Chip Testing (P-Chip), Trunk Group Testing (JI-POKTANG), Latex Group Testing (JIPOKTAH), Oil Group Testing (JIPOKMIN), Resin Group Testing (JIPOKSIN), appointed and dismissed by the Head of Hall on behalf of Director General.
- 9. Company is the Holder of Business License for Timber Forest Products Utilization (IUPHHK) in natural forest and plantation forest IUPHHK, Business License for Non-Timber Forest Products Utilization (IUPHHBK), License for Timber Forest Products Collection (IPHHK), License for Non-Timber Forest Product Utilization (IPHHBK), Business License for Timber and Non-Timber Forest Products Primary Industry in the from of Private-Owned Enterprises (BUMS), State-Owned Enterprise (BUMN) and Regional-Owned Enterprises and Registered Shelter.
- 10. Coaching in measurement and testing of forest product is activity to provide guidance in the implementation of forest products measurement and testing activities, technically and administratively.
- 11. Director General is Director General appointed for duties and liabilities in Forestry Business Management field.
- 12. Provincial Office is the Office appointed for duties and liabilities in forestry field in Province.
- 13. Regency/Municipal Office is the Office appointed

for duties and liabilities in forestry field in District/ City.

14. Hall is Technical Implementation Unit (UPT) of Directorate General of Forestry Business Management accordingly to its operational territory.

CHAPTER II PURPOSES AND OBJECTIVES

Article 2

Purposes of the implementation of measurement and testing of forest product are:

- To protect state rights upon forest products in the form of collection of Forest Resources Provision (PSDH) and/or Reforestation Fund (DR).
- To protect people's interest upon quality forest product whether in the aspect of ecology as well as economy.
- To improve forest products competitiveness and sustainable forest management.

Article 3

Objectives of the implementation of measurement and testing of forest product are:

- As calculation base for Forest Resources Provision (PSDH), Reforestation Fund (DR) and/or crop value compensation.
- b. To know sale price calculation
- As calculation base for company's profit-loss and employees' wage/salary.
- d. As base to determine quality and age of tree crop, whether from economy as well as ecology aspect.

CHAPTER III

PROCEDURES FOR MEASUREMENT AND EVALUATION OF FOREST PRODUCT

Article 4

- (1) All forest products from state forest are obliged to done measurement and testing upon by the authority officer/forest products examiner personnel.
- (2) All forest products from private forest are obliged to be done measurement and type determination upon by the Head of Village/Sub-District or appointed officer.

Article 5

- Equipments for forest products measurement are calibrated by the authority institution.
- (2) Equipments for forest products measurement are obliged to be reported to the Hall for registration.
- (3) Equipments, as meant at paragraph (1) and (2), and used by GANISPHPL are obliged to be provided by the company.
- (4) Equipments, as meant at paragraph (1) and (2), and used by WAS-GANISPHPI are obliged to be provided by the Provincial/Regency/Municipal Office.

Article 6

- (1) Measurement and testing as meant in Article 4 paragraph (1) are performed by GANISPHPL.
- (2) Measurement and testing of forest product are principally done on the ground or open space.
- (3) In case the measurement and testing of forest products is done in a room such as storehouse, in and/or on ship/pontoon, there must be proper lighting, so that observation upon object of measurement and testing can be performed.
- (4) In case measurement and testing of forest products in the form of roundwood must be done in

water, it is carried out under condition that at least ¼ (a quarter) of the roundwood trunk is floating on the water surface.

Article 7

Method for measurement and testing of forest products is regulated with Regulation of Director General.

Article 8

Upon measurement and testing of forest products done by GANISPHPL, as meant in Article 6 paragraph (1), WAS-GANISPHPL performs investigation, which result written on Investigation Official Report (BAP).

CHAPTER IV

COACHING

Article 9

- Director General carries out coaching and evaluation upon measurement and testing of forest products.
- (2) Local Head of Hall performs coaching and evaluation upon the implementation of measurement and testing of forest products done by GANI-SPHPL and WAS-GANISPHPL.
- (3) Coaching and evaluation as meant at paragraph(2), can be done by male or female.

CHAPTER V

REPORTING

Article 10

(1) GANISPHPL and WAS-GANISPHPL are obliged to report to Head of Hall in monthly basis as their main duties and functions accordingly to the laws

and regulations.

(2) Head of the Hall reports to Director General every 6 (six) months with copy to Head of Provincial Office and Head of Regency/Municipal Office.

CHAPTER VI

FINAL PROVISIONS

Article 11

This Regulation of Minister of Forestry starts to take effect since the promulgation date.

For everybody to acknowledge this regulation, this Regulation of Minister of Forestry is promulgated by placing it in the State Gazette of Republic of Indonesia.
