

**GENERAL GUIDELINE FOR DEVELOPMENT OF
PRESERVED FORESTRY BY RURAL COMMUNITY
(Regulation of the Minister of Forestry R.I.
Number P.8/Menhut-II/2013, dated January 28, 2013)**

WITH THE BLESSING OF THE ONE AND ONLY ONE

MINISTER OF FORESTRY OF

THE REPUBLIC OF INDONESIA,

by the Rural Community;

In view of:

Considering:

- a. the provision in Article 34 paragraph (1) letter f of Government Regulation Number 76 Year 2008, concerning Forest Rehabilitation and Reclamation, states that to support rehabilitation activity of forest and land which either of it is conducted by empowering activity of the community activity;
- b. to carry out such activity referred to in letter a, and in the context of curtailing poverty and joblessness in the rural area resulting from the decreasing quality of ecosystem, it is necessary to exercise Development of Preserved Forestry by the Rural Community (PPMPBK);
- c. based on the consideration referred to in letter a and letter b, it is necessary to stipulate Regulation of the Minister of Forestry concerning General Guideline for Development of Preserved Forestry

D E C I D E S:

To stipulate:

REGULATION OF THE MINISTER OF FORESTRY ON GENERAL GUIDELINE FOR DEVELOPMENT OF PRESERVED FORESTRY BY RURAL COMMUNITY.

Article 1

The General Guideline for PPMPBK as specified in the Attachment to this Regulation of the Minister of Forestry constitutes inseparable part of this Regulation of the Minister of Forestry.

Article 2

The General Guideline referred to in Article 1 constitutes as reference for implementation of the PPMPBK's activity.

Article 3

Activity of PPMPBK that has been carried out prior to enactment of this Regulation of the Minister of Forestry is hereby declared lawfully survives and applies, and further implementation thereof shall be adjusted to this Regulation of the Minister of Forestry.

Article 4

By the time this Regulation of the Minister of Forestry comes to force, Regulation of the Minister of Forestry Number P.15/Menhut-II/2012, concerning General Guideline for PPMBK as amended by Regulation of the Minister of Forestry Number P.27/Menhut-II/2012, is revoked and hereby declared null and void.

Article 5

This Regulation of the Minister comes to force on the date it is enacted.

For public cognizance, this Regulation of the Minister shall be announced by placing it in the State Gazette of the Republic of Indonesia.
