**DECREE OF THE MINISTER OF FORESTRY AND PLANTATIONS  
 NUMBER : 148/KPTS-II/2000 ; DATED : JUNI 7, 2000**

**THE DELIVERY OF A FOREST AREA TO THE EXTENT OF 12.050  
 (TWELVE THOUSAND FIFTY) HECTARES TO THE REGIONAL  
 ADMINISTRATION OF THE SOUTH SUMATRA PROVINCE, WHICH IS  
 LOCATED AT THE RAMBANG KAPAK TENGAH FOREST GROUP, MUARA  
 ENIM REGENCY, SOUTH SUMATRA PROVINCE**

THE MINISTER OF FORESTRY AND PLANTATIONS,

- Considering :**
- a. that on the basis of the Decree of the Minister of Forestry Number 38/Kpts-II/1996 dated January 29, 1996 to PT MUSI HUTAN PERSADA has been given the Exploitation Right on the Industrial Estate at an area of  $\pm$  296,400 (two hundred ninety six thousand four hundred) hectares, which is located in the South Sumatra Province;
  - b. that on March 2, 2000 a joint agreement has been made between the Department of Forestry and Plantation, the Regional Administration of the South Sumatera Province, PT MUSI HUTAN PERSADA, and the Village Members ex Marga Rambang Kapak Tengah I, Rambang Lubai District, Muara Enim Regency, which in essence declares that the forest area to an extent of  $\pm$  12,050 (twelve thousand fifty) hectares which is located in the Rambang

Kapak Tengah forest group, Muara Enim Regency, South Sumatera Province, be removed from the Timber Estate Exploitation Right of PT MUSI HUTAN PEPRSADA to be delivered to the Regional Administration of the South Sumatera Province.

- c. that in connection with the above mentioned matters, it is deemed necessary to deliver the area with an extent of  $\pm$  12,050 (twelve thousand fifty) hectares to the Regional Administration of the South Sumatera Province, with a Decree of the Minister of Forestry and Plantations.

11. Decree of the Minister of Forestry and Plantations Number 002/Kpts-II/2000 on the Organization and Working Procedure of the Department of Forestry and Plantations.

**Paying**

**Attention to** : Joint Agreement dated March 2, 2000 between the Department of Forestry and Plantations, the Regional Administration of the South Sumatera Province, PT MUSI HUTAN PERSADA, and Village Members ex Marga Rambang Kapak Tengah I, Rambang Lubai District, Muara Enim Regency.

**HAS DECIDED :**

**To Lay down :**

**FIRST** : To deliver the forest area with an extent of  $\pm$  12,050 (twelve thousand and fifty) hectares which is located in the Rambang Kapak Tengah forest group, Muara Enim Regency, South Sumatera Province, to the Regional Administration of the South Sumatera Province.

**SECOND** : The said forest area which will be delivered, shall henceforth be managed by the Regional Administration of South Sumatera and the proceeds used for the welfare of the community in and around the working area of PT

MUSI HUTAN PRASADA in general and the Village Members ex Marga Rambang Kapak Tengah I in particular.

- THIRD** : The delivery of management of the working area referred to in the FIRST Dictum constitutes a commitment of the Government to improve the prosperity of the community within and around the working area of PT MUSI HUTAN PERSADA.
- FOURTH** : The forest area with an extent of  $\pm$  12,050 (twelve thousand fifty) hectares mentioned in the FIRST dictum remains to be a production forest zone.
- FIFTH** : The plants/stands located within the forest area, the means, infrastructure and equipment within the forest area as mentioned in the FIRST Dictum shall remain the right of PT MUSI HUTAN PERSADA.
- SIXTH** : With the issuance of this Decree, the Regional Administration of the South Sumatera Province shall be responsible for the safeguarding of the plants/stands referred to in the FIFTH Dictum until it is ready for felling and the settlement of the indemnification between PT MUSI HUTAN PERSADA and the community.
- SEVENTH** : To order the Agency for Forest and Plantation Plaenology to coordinate the boundary arrangements in the field on the area with an extent of  $\pm$  12,050 (twelve thousand fifty) hectares mentioned in the FIRST Dictum.
- EIGHTH** : The location of the production forest zone with an extent of  $\pm$  12,050 (twelve thousand fifty) hectares is as indicated in the attached map.
- NINTH** : This decree comes into force as of the date it is laid down.
