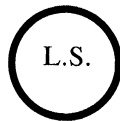
I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No 27 of 1972) and for the purpose of giving effect to Council Directive No. 93/119/EEC of 22 December 1993¹, Council Directive 98/58/EC of 20 July 1998², Council Directive No. 1999/74/EC of 19 July 1999³ and Commission Directive 2002/4/EC of 30 January 2002⁴, Council Directive No 2007/43/EC of 28 June 2007⁵, Council Directive No. 2008/119/EC of 18 December 2008⁶ and Council Directive No. 2008/120/EC of 18 December 2008⁷, hereby make the following Regulations—

1. These Regulations may be cited as the European Communities (Welfare of Farmed Animals) (Amendment) Regulations 2012.

2. The European Communities (Welfare of Farmed Animals) Regulations 2010 are amended—

(a) in Regulation 41(1) (i), by the insertion after “on” of “summary”, and

(b) in Regulation 41 (2), by the substitution for “A summary offence under these Regulations may be prosecuted by the Minister” of “An offence under these Regulations may be prosecuted in a summary manner by the Minister”.
