FOOD SAFETY AUTHORITY OF IRELAND ACT 1998 (AMENDMENT OF FIRST AND SECOND SCHEDULES) ORDER 2017

I, MARCELLA CORCORAN KENNEDY, Minister of State at the Department of Health, in exercise of the powers conferred on me by section 5 of the Food Safety Authority of Ireland Act 1998 (No. 29 of 1998) (as adapted by the Health and Children (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 219 of 2011)) and the Health (Delegation of Ministerial Functions) (No. 4) Order 2016 (S.I. No. 512 of 2016), after consultation with the Minister for Agriculture, Food and the Marine and the Minister for Communications, Climate Action and Environment, hereby order as follows:

1. This Order may be cited as the Food Safety Authority of Ireland Act 1998 (Amendment of First and Second Schedules) Order 2017.

2. In this Order—
