# EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING AGRICULTURE PLANT SPECIES) (AMENDMENT) REGULATIONS 2020

I, Michael Creed, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2019/1985 of 28 November 2019 <sup>1</sup>, hereby make the following regulations:

- 1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2020.
- 2. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) Regulations 2004 (S.I. No. 122 of 2004) are amended by substituting in Regulation 2 for the definition of "Directive" (as amended by the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2019 (S.I. No. 302 of 2019) the following-

"'Directive' means Commission Directive No. 2003/90/EC of 6 October 2003<sup>2</sup> as amended by Commission Implementing Directive (EU) 2019/1985 of 28 November 2019;".

3. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2019 (S.I. No. 302 of 2019) are revoked
