**European Communities (Pesticide Residues) (Foodstuffs of Animal Origin)
(Amendment) Regulations, 2002**

1. (1) These Regulations may be cited as the European Communities (Pesticide Residues) (Foodstuffs of Animal Origin) (Amendment) Regulations, 2002.

(2) These Regulations shall come into operation in respect of Lindane and Quintozene on 1 December 2002, in respect of Bentazone, Pyridate and Oxydemetonmethyl on 1 January 2003, respect of Parathion on 1 May 2003 and in respect of abamectin, azocyclotin and cyhexatin, bifenthrin, bitertanol, bromopropylate, clofentezine, cyromazine, fenpropimorph, flucytrinate, methacrifos, myclobutanil, penconazole, prochloraz, profenofos, Resmethrin, Tridemorph, and triadimefon and triadimenol on 1 August 2003.
