- 1. These Regulations may be cited as the European Communities (Pesticide Residues) (Products of Plant Origin including Fruit and Vegetables) (Amendment) Regulations 2005 and come into operation on 26 March 2005.
- 2. The European Communities (Pesticide Residues) (Products of Plant Origin including Fruit and Vegetables) Regulations 1999 (S.I. No. 179 of 1999) is amended in Regulation 2 (1) by substituting for "Directive" the following -
