**European Communities (Authorization, Placing on the Market,
Use and Control of Plant Protection Products) (Amendment)
Regulations 2005**

I, Mary Coughlan, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive 2005/2/EC of 19 January 2005¹ and Commission Directive 2005/3/EC of 19 January 2005² hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) (Amendment) Regulations 2005.
2. The European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) Regulations 2003 (S.I. No. 83 of 2003) are amended, in Regulation 2(1), by substituting for the definition of “Directive of 1991” the following-

Explanatory Note

(This note is not part of the instrument and does not purport to be a legal interpretation)

These Regulations give effect to Commission Directive 2005/2/EC of 19 January 2005 and Commission Directive 2005/3/EC of 19 January 2005. These Directives, which amend Council Directive 91/414/EEC concerning the placing of plant protection products on the market, provide for the inclusion of the active substances *Ampelomyces quisqualis*, *Gliocladium catenulatum*, Imazosulfuron, Laminarin, Methoxyfenozide and S-Metolachlor.
