## EUROPEAN COMMUNITIES (LABELLING AND MARKETING STANDARDS FOR POULTRYMEAT) (AMENDMENT) REGULATIONS 2007

- I, MARY COUGHLAN, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Council Regulation (EC) No. 1029/2006 of 19 June 2006<sup>1</sup>, Commission Regulation (EC) No. 814/2004 of 29 April 2004<sup>2</sup>, Commission Regulation (EC) No. 81/2006 of 18 January 2006<sup>3</sup>, Commission Regulation (EC) No. 433/2006 of 15 March 2006<sup>4</sup> and Commission Regulation (EC) No. 2029/2006 of 22 December 2006<sup>5</sup>, hereby make the following regulations—
- 1. These Regulations may be cited as the European Communities (Labelling and Marketing Standards for Poultrymeat) (Amendment) Regulations 2007.
- 2. The European Communities (Labelling and Marketing Standards for Poultrymeat) Regulations 2004 (S.I. No. 42 of 2004) are amended by—

## **EXPLANATORY NOTE**

(This note is not part of the instrument and does not purport to be a legal *interpretation*)

These Regulations give effect to certain European Union legislation on marketing standards for poultrymeat and provide a derogation from that legislation for small quantities.
