Food Safety Authority of Ireland Act 1998 (Amendment of First and Second Schedules) Order 2006.

I, Sean Power, Minister of State at the Department of Health and Children, in exercise of the powers conferred on me by section 5 of the Food Safety Authority of Ireland Act 1998 (No. 29 of 1998) and the Health and Children (Delegation of Ministerial Functions) (No. 3) Order, 2004 ([S.I. No. 844 of 2004](#)), after consultation with the Minister for Agriculture and Food, the Minister for the Environment, Heritage and Local Government and the Minister for Communications, Marine and Natural Resources hereby order as follows:
