

REGULATIONS

Resolution No. (67)

Date : 11th. Rabia Al- Awal, 1416 H.

7-8-1995 A.D.

In accordance with the provisions of Para. (A) of Article (42) of the Constitution.

The Revolutionary Command Council have decided the following:-

Firstly - A general Body in the name of (The General Body For Operating and Maintaining Saddam River shall be created and be added to the general bodies mentioned in Item (Secondly / A) of Article (4) of the Law of Ministry of Irrigation No. (8) of 1993.

Secondly - There shall be applied on the staff of the created Body the provisions of Law of Agricultural Administrations No. (50) of 1972.

Thirdly - The affiliated member in sights of work of the Body shall be granted fixed allowances in a ratio of (25%) percent of his monthly salary and his firm ed allowances.

Fourthly - There shall be defined with instructions issued by Minister of Irrigation the formations of the Body and its tasks and duties.

Fifthly - This Resolution shall come into force from the date of its publication in the Official Gazette.

The Second Amendment to the Regulation of General Examination No. (18) of 1987

Article - 1 -

The text of Article Six of the General Regulation No. (18) of 1987 shall be the Item Firstly thereto and the following shall be added to it and to be its Item (Secondly):-

Secondly - The Minister of Education may exempt the students being mentioned in Item (Firstly) of this Article of performing the general examination in the English subject and the additional foreign language accredited in teaching at the Primary and secondary schools in the repeating year only in case of being not studying such language in the country where were residing therein.

Article - 2 -

This Regulation shall come into force from the date of its publication in the Official Gazette.
