THE COTTON LINT AND SEED MARKETING REGULATIONS

1. These Regulations may be cited as the Cotton Lint and Seed Marketing Regulations.
2. Licences issued by the Board under section 16 of the Act to persons who shall be eligible to purchase cotton lint from the Board shall be in form 1 in the Schedule, and shall be issued subject to payment of a fee of five hundred shillings for each licence.
3. Licences issued by the Board under section 16 of the Act to persons who shall be eligible to purchase cotton seed from the Board shall be in form 2 in the Schedule, and shall be issued subject to the payment of a fee of fifty shillings for each licence.
4. Cotton Lint and Cotton Seed Supervisors appointed by the Board under section 15 of the Act shall have, and may exercise, within the province, district or division in respect of which they have been appointed, power -
 - (a) to supervise such arrangements for the purchase, sale and export of cotton lint and cotton seed as may be required by the Board;
 - (b) to inspect seed cotton held by ginneries for ginning in stores, ginneries or in transit;
 - (c) to inspect ginning;
 - (d) to inspect cotton lint and cotton seed held by ginneries in ginneries or stores or in transit; and
 - (e) to take samples and certifying weights and qualities of cotton lint and cotton seed as may be required by the Board.
