FISHERIES (VESSEL LICENCES) Regulation (No. 1) OF 1982

In exercise of the powers conferred by section 22 of the Fisheries Ordinance (Cap. 33), the Beretitenti, acting in accordance with the advice of the Cabinet makes the following Regulations:-

1. This Regulation may be cited as the Fisheries (Vessel Licences) Regulation (No. 1) of 1982.
2. The Fisheries (Vessel Licences) Regulations of 1981 are hereby amended by repealing Schedule 1 and substituting the following Schedule:-

C O N D I T I O N S

- 1. The registered number of the vessel is to be painted in white letters and numbers on a black background, or in black letters and numbers on a white background, and the number shall be painted on such part of the vessel as the licensing officer shall stipulate in condition 2.  
 The minimum size of the number shall be as follows:  
 Vessels over 20 metres L.O.A. 1 metre high x 125mm wide  
 Vessels over 7 metres L.O.A. but under 20 metres L.O.A. - 500mm high x 65mm wide.
