IMPORTATION AND EXPORTATION OF LIVESTOCK AND LIVESTOCK PRODUCTS

To amend and consolidate the laws relating to the importation into and the exportation from Basutoland of livestock and livestock products.

[21st January, 1953]

Interpretation.

- 1. In this Proclamation, unless the context otherwise requires—
 - "bastard goat" means any Boer goat or any goat which does not carry mohair, but does not include the Swiss goat;
 - "bastard sheep" means any sheep not carrying Merino wool or any sheep carrying wool known as "Coarse and Coloured";
 - "export" means to remove from Basutoland for any purpose whatsoever;
 - "import" means to introduce into Basutoland for any purpose whatsoever;
 - "inspecting officer" means any officer or member of a class of officer designated by the Principal Veterinary Officer, by Notice in the *Gazette*, to carry out inspections under this Proclamation;
 - "livestock" means any member of the animal kingdom which the High Commissioner, may by Notice in the Gazette, declare to be livestock for the purposes of this Proclamation, and includes cattle, sheep, goats, horses, mules, donkeys, pigs, dogs and cats; and—
 - (a) all primates, other than man;
 - (b) all rodents;
 - (c) all ungulates;
 - (d) all insectivora;
 - (e) all carnivora;
 - (f) elephants;
 - (g) all equine animals;
 - (h) all birds, including poultry;

"livestock products" means unprocessed hides, skins, bones, horns, hooves or hair of livestock, other than wool or mohair;(1)

- "port of entry" and "port of exit" mean any place prescribed as a port of entry or exit respectively in terms of sub-section (1) of section *five*;
- "undesirable livestock" means any livestock considered by an inspecting officer to be lacking in constitution, size, conformation, soundness and type for the improvement of livestock in Basutoland and includes bastard sheep and goats.
- 2. (1) Any person who imports or exports or causes or allows to be imported into or exported from Basutoland, any livestock or livestock products except under a permit issued by the Principal Veterinary Officer or by any person designated by him to issue such permits, or who infringes any of the conditions set out in the said permit, shall be guilty of an offence.

Restrictions on the importation and exportation of livestock or livestock products.

- (2) Every such permit shall be on the appropriate form as set forth in the Schedule to this Proclamation.
- (3) No permit shall be granted for the importation of undesirable livestock.
- (4) Any person who imports into Basutoland any livestock in respect of which an import permit has been issued in terms of sub-section (1) of this section without first having such permit endorsed at a port of entry by an inspecting officer, shall be guilty of an offence: Provided that this sub-section shall not apply to the importation of dogs, cats, pigs or poultry.
- 3. (1) Any person who uses any livestock for riding pack or transport purposes between Basutoland and the Union of South Africa, except under a Transport Permit issued by the Principal Veterinary Officer or by any person designated by him to issue such permits, or who infringes any of the conditions set out in the said permit, shall be guilty of an offence.

Restrictions on use of livestock for transport between Basutoland and the Union.

- (2) Every such permit shall be on the appropriate form as set forth in the Schedule to this Proclamation.
- 4. Subject to the provisions of sub-section (3) of section two, any officer authorised to grant any permit under the provisions of this Proclamation may, in his discretion, refuse to grant such permit or may grant it subject to such additional conditions as he may endorse thereon: Provided that any person to whom the grant of a permit has been

Power to refuse a permit or to impose conditions.

refused in terms of this section, or who objects to any condition imposed, may appeal in writing to the Resident Commissioner whose decision shall be final.

Ports of entry and exit.

- 5. (1) The Resident Commissioner may, by Notice in the Gazette, prescribe places to be known as ports of entry, or exit, as the case may be, at which livestock or livestock products or any particular species of livestock may be imported into or exported from Basutoland.
- (2) Any person who imports into or exports from Basutoland any livestock except through a prescribed port of entry or exit shall be guilty of an offence.
- (3) The Principal Veterinary Officer may, by Notice in the Gazette, direct that livestock or any class of livestock may be imported into Basutoland only on days and at times stated in such notice.
- (4) Any person who exports any livestock products from Basutoland except through an appropriate port of exit shall be guilty of an offence.

Penalties and disposal of illegally imported livestock and livestock products.

- (2)6. (1) Any person who contravenes sub-section (1), or sub-section (4) of section *two*, or sub-section (1) of section *three*, or sub-section (2) or sub-section (4) of section *five* of this Proclamation shall be liable on conviction to a fine not exceeding two hundred rands, or in default of payment, to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.
- (2) The Court shall, when passing sentence, give directions as to the disposal of any livestock or livestock products proved to have been illegally imported into Basutoland by declaring such livestock or livestock products to be forfeited to the Crown or by ordering that such livestock or livestock products be destroyed without compensation to the owner and at his expense: Provided that the Court may, in its discretion order that such forfeiture or destruction shall only take effect if, after the expiration of a specified period, such livestock or livestock products have not been removed from Basutoland.

Short title and commencement. 7. This Proclamation may be cited as the Basutoland Importation and Exportation of Livestock and Livestock Products Proclamation, and shall come into operation at the expiration of two months from the date of promulgation thereof.(3)
