

The regulations for the state supervision of land reclamation works (adopted by Government's decision Nr. 223 31 March 1994)

General Provisions

1. The purpose of the state supervision of land reclamation works (further referred to as supervision) is to guarantee the enforcement of laws and projecting and construction rules during land reclamation works.
2. The supervision is carried out by officers authorized by the Ministry of Agriculture and also by officers of land reclamation services authorized by district municipalities.
3. The officers mentioned in the article 2 supervise, in compliance of the decisions and decrees of the Government of the Republic of Lithuania, other regulations, projecting and construction rules, also the present regulations, the process of construction, reconstruction and restoration of land reclamation facilities and maintenance of buildings, until they are in use, non depending on their purpose, form of ownership and method of construction.

Rights and obligations of the officers authorized to carry out supervision by the Ministry of Agriculture

4. Officers authorized to carry out supervision by the Ministry of Agriculture supervise:
 - 4.1. Whether projecting and construction rules and normatives are observed, what is the quality of the construction works, whether they correspond to the project.
 - 4.2. Whether environmental requirement contained in the project and other compulsory environmental requirements are observed.
 - 4.3. How the officers of state land reclamation services which are authorized to carry out supervision by district municipalities carry out their work.
 - 4.4 Whether technical supervision and supervision by the author of project are efficient.
5. Officers mentioned in the article 4 participate when:
 - 5.1 State quality control inspection controls whether construction materials, other construction inputs and construction of buildings itself meet requirement of state standards.
 - 5.2. Accidents which have led to the collapse or deformation of land reclamation and hydrotechnic facilities are investigated.
 - 5.3 Certification of the officers of state land reclamation services authorized by district municipalities to carry out supervision is done
6. Officers indicated in the article 4 have the right to:
 - 6.1. To get from constructors, work superintendents, users and owners documents and data necessary to carry out supervisions indicated in these regulations;
 - 6.2 To require from constructor or constructing enterprise to unearth constructions (drainage and other pipes), to prove the suitability of soil, materials and constructions
 - 6.3. To require from constructors, work superintendants, users and

owners that they remove defects and provide information about carrying out this requirement.

6.4. To declare invalid the document about taking in use land reclamation facilities, if their construction is not completed, if the document was issued with grave violations of existing procedures or if the facilities cannot be properly used.

6.5 To present constructors, work superintendents, users and owners findings about technical supervision and supervision by the author of project(?).

Rights and obligations of state land reclamation service officers who are authorized by district municipalities to carry out supervision

7. State land reclamation service officers who are authorized by district municipalities to carry out supervision control and supervise:

7.1. Whether projecting norms and regulation are observed, what is quality of land reclamation facilities being constructed, whether they are made according to the project;

7.2 Whether environment protection measures included into the project or other environmental regulations are observed.

7.3. Documents on sub-soil constructions and documents on technologic control.

7.4 Whether there is permission for construction works and it is properly registered.

7.5 Whether land owners and user perform small maintenance works on land reclamation facilities properly and in time

8. Officers mentioned in article 7 have right to:

8.1 to inspect without any hindrances land reclamation facilities which are in construction or in use, to obtain from builders, work executors, users or owners all documents necessary to carry out all the examination mentioned in this regulation.
