

# **MALAYSIAN RUBBER BOARD (LICENSING) (AMENDMENT) REGULATIONS 2002**

**PU(A) 22/2002**

IN exercise of the powers conferred by section 62 of the Malaysian Rubber Board (Incorporation) Act 1996 [Act 551], the Minister makes the following regulations:

## **1. Citation and commencement.**

(1) These regulations may be cited as the **Malaysian Rubber Board (Licensing) (Amendment) Regulations 2002.**

(2) These Regulations come into operation on 1 February 2002.

## **2. Amendment of regulation 1.**

The Malaysian Rubber Board (Licensing) Regulations 1997 PU. (A) [516/97], which are referred to as the "principal Regulations" in these Regulations, are amended in subregulation 1(4) by inserting after the words "all rubber" the words "and rubber gloves".

## **3. Amendment of regulation 2.**

Regulation 2 of the principal Regulations is amended-

(a) by substituting for the definition of "to ship rubber for export" the following definition:

"to ship rubber or rubber gloves for export" means to ship rubber or rubber gloves from Malaysia for export to any country or place outside Malaysia; and

(b) by inserting after the definition of "permit" the following definition:

"rubber gloves" means gloves made wholly or partly from natural or synthetic rubber;'

## **4. Amendment of Part IV.**

The heading of Part IV of the principal Regulations is amended by inserting after the words "EXPORT OF RUBBER," the words "RUBBER GLOVES,".

## **5. Amendment of regulation 37.**

Subregulation 3 7(1) of the principal Regulations is amended-

(a) in the national language text, by substituting for the word "dikelurakan" the word "dikeluarkan"; and

(b) in paragraph (b), by inserting after the words "ship rubber" the words "or rubber gloves".

## **6. Amendment of regulation 38.**

Regulation 38 of the principal Regulations is amended-

(a) by inserting after subregulation (1) the following subregulation:

"(1A) No person shall export rubber gloves unless the person holds a valid certificate issued under regulation 43 to ship rubber gloves for export."; and

(b) in subregulation (2), by inserting after the words "subregulation (1A) " the words "or (1A)".

## **7. Amendment of regulation 42.**

Regulation 42 of the principal Regulations is amended-

(a) by substituting for subsection (1) the following subsection:

"(1) An application for a certificate to carry on the activity of packing rubber for export or shipping rubber for export referred to in regulations 37 and 38 shall be made in Form 3 to the Certification Panel."; and

(b) by inserting after subregulation (1) the following subregulation:

"(1A) An application for a certificate to carry on the activity of shipping rubber gloves for export referred to in regulations 37 and 38 shall be made in the form prescribed by the Board."

**8. Amendment of regulation 44.**

Regulation 44 of the principal Regulations is amended in subregulation (2) by inserting after the words "Form 3" the words "or in the form specified by the Board".

**9. Amendment of regulation 62.**

Regulation 62 of the principal Regulations is amended

(a) in subregulation (1)

(i) by deleting the word "and" appearing at the end of paragraph (b);

(ii) by substituting for paragraph (c) the following paragraph:

"(c) the shipper's certificate number; and"; and

(iii) by inserting after paragraph (c) the following paragraph:

"(b) Produce of Malaysia (P.O.M)."; and

(b) by inserting after subregulation (1) of the following subregulation:

"(1A) Every package of rubber gloves for export shall bear the following markings:

(a) the type of rubber gloves contained in the package, which shall be a type recognized by the rubber gloves industry and approved by the Board;

(b) the shipper's certificate number; and

(c) Produce of Malaysia (P.O.M)."

**10. Amendment of regulation 63.**

Regulation 63 of the principal Regulations is amended

(a) in subregulation (1)-

(i) by inserting after the words "package of rubber" the words "or rubber gloves"; and

(ii) by inserting after the words "grade of rubber" the words "or type of rubber gloves"; and

(b) in subregulation (3), by substituting for the words "is found to contain rubber of a grade other than the grade" the words "or rubber gloves is found to contain rubber or rubber gloves of a grade or type other than the grade or type".

**11. Amendment of regulation 65.**

Regulation 65 of the principal Regulations is amended

(a) in the marginal note, by substituting for the words "Books of account, etc." the words "Written records and documents";

(b,) in subregulation (1), by substituting for the words "books of account" the words "written records and documents of the quantity and description of the rubber or rubber gloves";

(c) in subregulation (2), by substituting for the words "Books of account" the words "Written records and documents";

(d) by substituting for subregulation (3) the following subregulation:

"(3) A holder of a certificate to ship rubber or rubber gloves for export shall in addition keep copies of all shipping instructions and any other document relevant to the rubber or rubber gloves being shipped for export."; and

(e) by deleting subregulation (4).

**12. Amendment of regulation 66.**

Regulation 66 of the principal Regulations is amended

(a) in the marginal note, by substituting for the words "Retention of documents" the words "Retention of written records and documents"; and

(b) by substituting for the words "Books of account and document" the words "Written records and documents".

**13. Amendment of Second Schedule.**

The Second Schedule to the principal Regulations is amended by substituting for Form 7 the following Form:
