BIS-SAHHA tas-setgħat mogħtija bl-artikolu 97 ta' l-Att dwar l-Ambjent u l-Ippjanar ta' l-Iżvilupp, il-Prim Ministro stabbilixxa d-dati hawn taħt imsemmija meta l-Att dwar l-Ippjanar tal-Iżvilupp, Kap. 356, għandu jithassar:-

- (a) it-30 ta' Novembru, 2010 bħala d-data meta d-dispożizzjonijiet ta' l-artikoli 3 sa 12, 16, 16A, 17, 17A, 17B, 17D, 26, 26A, 27(1) u (2)(a) sa (h), 29, 29A, 29B, 29C, 31, 32A, 36A, 38, 39, 39A, 41 sa 51, 57, 59, 60, 62, 63 u Skeda 1 sakemm din tirrigwarda l-Awtorita` u ta' Skeda 2 li jinsabu ma' l-Att għandhom jithassru;
- (b) it-13 ta' Dicembru, 2010 bħala d-data meta d-dispożizzjonijiet ta' l-artikolu 13 u ta' Skeda 1 li jinsabu ma' l-Att għandhom jithassru;
- (c) il-31 ta' Dicembru, 2010 bħala d-data meta d-dispożizzjonijiet ta' l-artikoli 30, 32, 33 sa 36, 37, 40, 52 sa 55, 55A, 55B, 58, 61 u 61A tal-Att għandhom jithassru; u
- (d) kull data oħra li għad tista' tiġi stabbilita fir-rigward tat-ħassir tad-dispożizzjonijiet l-oħra tal-imsemmi Att.

L.N. 512 of 2010**ENVIRONMENT AND DEVELOPMENT PLANNING ACT
(CAP. 504)****Development Planning Act (Repeal) Notice, 2010**

IN EXERCISE of the powers conferred by article 97 of the Environment and Development Planning Act, 2010, the Prime Minister has established the following dates for the repeal of the provisions of the Development Planning Act, Cap. 356:-

- (a) the 30th November, 2010 as the date when the provisions of articles 3 to 12, 16, 16A, 17, 17A, 17B, 17D, 26, 26A, 27(1) and (2)(a) to (h), 29, 29A, 29B, 29C, 31, 32A, 36A, 38, 39, 39A, 41 to 51, 57, 59, 60, 62, 63 and Schedule 1 in so far as it relates to the Authority and Schedule 2 to the Act shall be repealed;
- (b) the 13th December, 2010 as the date when the provisions of article 13 and Schedule 1 to the Act shall be repealed;
- (c) the 31st December, 2010 as the date when the provisions of articles 30, 32, 33 to 36, 37, 40, 52 to 55, 55A, 55B, 58, 61 and 61A to the Act shall be repealed; and
- (d) such further date as may be established with regard to the repeal of the remaining provisions of the said Act.
