The title of these regulations is the Prevention and Remedying of Environmental Damage (Amendment) Regulations, 2011, and they shall be read and construed as one with the Prevention and Remedying of Environmental Damage Regulations, 2008, hereinafter referred to as “the principal regulations”. |

| Amends Schedule III to the principal regulations. | 2. Immediately after paragraph 12 of Schedule III to the principal regulations, there shall be added the following new paragraphs: |
| L.N. 22 of 2009. | “(13) The management of extractive waste pursuant to the Waste Management (Management of Waste from Extractive Industries and Backfilling) Regulations, 2009. |
| L.N. 346 of 2011. | (14) The operation of storage sites pursuant to the Geological Storage of Carbon Dioxide Regulations, 2011.”. |
