(KAP. 504)****Regolamenti tal-2011 li jemendaw ir-Regolamenti dwar il-Konservazzjoni tal-Ghasafar Selvaġġi (Emenda Nru.2)**

BIS-SAHHHA tas-setgħat mogħtijin bl-artikoli 61 u 62 tal-Att dwar l-Ambjent u l-Ippjanar tal-Iżvilupp, il-Prim Ministru għamel dawn ir-regolamenti li ġejjin:-

1. (1) It-titlu ta' dawn ir-regolamenti hu Regolamenti tal-2011 li jemendaw ir-Regolamenti dwar il-Konservazzjoni tal-Għasafar Selvaġġi (Emenda Nru.2) u għandhom jinqraw u jiftieħmu haġa waħda mar-Regolamenti dwar il-Konservazzjoni tal-Għasafar Selvaġġi, hawn iżjed 'il quddiem msejħha bhala “r-regolamenti prinċipali”.
Titolu. L.S. 504.71.

2. Fil-proviso tal-paragrafu (b) tas-subregolament (6) tar-regolament 10 tar-regolamenti prinċipali, il-kliem “ir-rakkmandazzjoni għandha tiġi sottomessa lill-Ministru għall-inqas ġimġħatejn qabel ma jkun propost li jibda l-istaġun miftuh li fih tkun permessa l-kacċa” għandhom jiġu sostitwiti bil-kliem “ir-rakkmandazzjoni għandha tiġi sottomessa lill-Ministru għall-inqas ġimġħatejn qabel ma jkun propost li jibda l-istaġun miftuh li fih ikun permess l-insib”.

Emenda tar-regolament 10 tar-regolamenti prinċipali.

**ENVIRONMENT AND DEVELOPMENT PLANNING ACT
(CAP. 504)****Conservation of Wild Birds (Amendment) (No. 2) Regulations, 2011**

BY VIRTUE of the powers conferred by articles 61 and 62 of the Environment and Development Planning Act, the Prime Minister has made the following regulations:

Title.

1. (1) The title of these regulations is the Conservation of Wild Birds (Amendment) (No.2) Regulations, 2011 and these regulations shall be read and construed as one with the Conservation of Wild Birds Regulations, hereinafter referred to as "the principal regulations".

Amendment of regulation 10 of the principal regulations.

2. In the proviso to paragraph (b) of sub-regulation (6) of regulation 10 of the principal regulations, for the words "the recommendation shall be submitted to the Minister at least two weeks prior to the proposed start of the open season during which hunting may be allowed" there shall be substituted the words "the recommendation shall be submitted to the Minister at least two weeks prior to the proposed start of the open season during which taking may be allowed".
