| <p>1. The title of these Regulations is Foot and Mouth Disease (Prevention) Regulations.</p> | <p>Title.</p> |
| <p>2. In these Regulations, the expression "approved pen" means any place approved in writing by the Principal Government Veterinary Surgeon, in which cattle imported from abroad may be kept.</p> | <p>Interpretation.</p> |
| <p>3. Goats intended to be shipped to Gozo shall be conveyed to the civil abattoir, on Tuesdays and Thursdays from 2 p.m. to 3 p.m., and kept there at the risk and expense of the owner, until tested for undulant fever.</p> | <p>Goats intended to be shipped to Gozo.</p> |
| <p>4. Goats found to give a positive test shall not be allowed to be exported; they shall be slaughtered, and compensation shall be paid in terms of regulations in force. Goats found not to give a positive test shall be so certified and shall be shipped to Gozo only from the Jetties Wharf in the Grand Harbour.</p> | <p>Tests.</p> |
| <p>5. Animals intended to be shipped to Gozo shall be conveyed to the landing place at Jetties Wharf for inspection by the Principal Government Veterinary Surgeon or his representative before shipment.</p> | <p>Goats shipped to Gozo to be inspected.</p> |
| <p>6. If any animal is found to be affected with foot-and-mouth disease, it may be removed to the quarantine station and kept there under observation for such period at the Superintendent of Public Health may require, or subjected to any other sanitary precautions which that officer may see fit to impose.</p> | <p>Removal of animal if found to be affected.</p> |
| <p>7. All imported cattle shall be escorted from any approved landing place to an approved pen or to the Lazzaretto.</p> | <p>Imported cattle.</p> |
| <p>8. All approved pens shall be kept in quarantine at the expense of the owner and access thereto shall be allowed only to persons provided with a written permit granted by the Principal Government Veterinary Surgeon.</p> | <p>Approved pens.</p> |
| <p>9. No cattle, offal, fodder, litter, or dung shall be removed from any approved pen without the permission in writing of the Principal Government Veterinary Surgeon who may refuse such permission or grant permission under such conditions and restrictions as he may deem fit.</p> | <p>Permission in writing.</p> |
| <p>10. All persons, animals, conveyances and utensils coming in contact with the cattle shall be disinfected, as may be directed by the Principal Government Veterinary Surgeon.</p> | <p>Disinfection.</p> |
