ECO-CONTRIBUTION ACT (CAP. 473)

Eco-Contribution Act (Amendment of First Schedule) Regulations, 2007

IN exercise of the powers conferred by article 13(c) of the Eco-Contribution Act, hereinafter referred to as "the Act", the Minister for Rural Affairs and the Environment, with the concurrence of the Prime Minister and Minister of Finance, has made the following regulations:-

1. (1) The title of these regulations is the Eco-Contribution Act Title and (Amendment of First Schedule) Regulations, 2007, and they shall be read and construed as one with the First Schedule to the Eco-Contribution Act, which First Schedule is hereinafter referred to in these regulations as "the Schedule".

(2) These regulations shall come into force on the 6th July, 2007.
