**FOOD SAFETY ACT
(CAP. 449)**

**Dietary Foods for Special Medical Purposes (Amendment)
Regulations, 2007**

IN exercise of the powers conferred by article 10 of the Food Safety Act, the Minister of Health, the Elderly and Community Care has made the following regulations:-

1. The title of these regulations is the Dietary Foods for Special Medical Purposes (Amendment) Regulations, 2007, and they shall be read and construed as one with the Dietary Foods for Special Medical Purposes Regulations, 2001, hereinafter referred to as “the principal regulations”. Citation.
L.N. 309 of 2001.

2. These regulations shall be deemed to have come into force on the 1st January, 2007, provided that products which do not comply with the provisions of these regulations, but which comply with the provisions of the Dietary Foods for Special Medical Purposes Regulations, 2001, may continue to be sold till 31st December, 2007. Commencement.

3. These regulations implement the provisions of Commission Directive 2006/82/EC of the 23rd October, 2006. Scope.

4. For regulation 6.1 of the principal regulations there shall be substituted the following:- Amends regulation
6 of the principal
regulations.

“6.1 (a) The name under which dietary foods for special medical purposes are sold shall be respectively:

in Maltese:

“Tkel dijetetiku għal skopijiet mediċi speċifiċi”

in English:

“Food(s) for special medical purposes”

in Italian:

“Alimento dietetico destinato a fini mediċi speciali”

(b) Without prejudice to paragraph (a) hereof, the list provided for in the Second Schedule specifies the names under which dietary foods for special medical purposes are sold in all the European Community languages.”

Amends the
Schedule to the

5. The title of the Schedule to the principal regulations shall be amended to read “First Schedule”.

Adds the Second
Schedule to the
principal
regulations.

6. The following shall be added as the Second Schedule immediately after the First Schedule as renumbered, to the principal regulations:-

“Second Schedule

Names under which dietary foods for special medical purposes are sold, in all the European Community languages:

- in Bulgarian: “Диетични храни за специални медицински цели”
- in Spanish: “Alimento dietético para usos médicos especiales”
- in Czech: “Dietní potravina určená pro zvláštní lékařské účely”
- in Danish: “Levnedsmiddel/Levnedsmidler til særlige medicinske formål”
- in German: “Diätetisches/Diätetische Lebensmittel für besondere medizinische Zwecke (Bilanzierte Diäten)”
- in Estonian: “Toit meditsiinilisel näidustusel kasutamiseks”
- in Greek: “Διαιτητικά τρόφιμα για ειδικούς ιατρικούς σκοπούς”
- in English: “Food(s) for special medical purposes”
- in French: “Aliment(s) diététique(s) destiné(s) à des fins médicales spéciales”
- in Italian: “Alimento dietetico destinato a fini medici speciali”
- in Latvian: “Diētiskā pārtika cilvēkiem ar veselības traucējumiem”
- in Lithuanian: “Specialios medicininės paskirties maisto produktai”
- in Hungarian: “Speciális – gyógyászati célra szánt – tápszer”
- in Maltese: “Ikkel dijetetiku għal skopijiet mediċi speċifiċi”
- in Dutch: “Dieetvoeding voor medisch gebruik”
- in Polish: “Dietetyczne środki spożywcze specjalnego przeznaczenia medycznego”
- in Portuguese: “Produto dietético de uso clínico”
- in Romanian: “Alimente dietetice pentru scopuri medicale speciale”
- in Slovak: “dietetická potravina na osobitné lekárske účely”
- in Slovenian: “Dietno (dietetično) živilo za posebne zdravstvene namene”
- in Finnish: “Kliininen ravintovalmiste/kliinisiä ravintovalmisteita”
- in Swedish: “Livsmedel för speciella medicinska ändamål”.
