Regolamenti ta' l-2008 li jemendaw ir-Regolamenti dwar
il-Bijočidi (Emenda Nru. 2)

BIS-SAHHA tas-setghat moghtija bl-artikoli 4 u 5 ta' l-Att dwar il-Kontroll tal-Pestičidi, il-Ministru ghar-Riżorsi u Affarijiet Rurali, wara li kkonsulta lill-Prim Ministru u lill-Ministru għall-Politika Soċjali, għamel dawn ir-regolamenti li ġejjin:-

1. (1) It-titolu ta' dawn ir-regolamenti hu **Regolamenti ta' l-2008 li jemendaw ir-Regolamenti dwar il-Bijočidi (Emenda Nru. 2)**, u għandhom jinqraw u jiftiehm u bħala haġa waħda mar-Regolamenti ta' l-2004 dwar il-Bijočidi, hawn iżjed 'il quddiem imsejhin "ir-regolamenti prinċipali".

(2) L-iskop ta' dawn ir-regolamenti hu li jitrassponu d-Direttiva tal-Kummissjoni 2007/69/KE tad-29 ta' Novembru 2007 li temenda d-Direttiva 98/8/KEE tal-Parlament Ewropew u tal-Kunsill biex *difethialone* tiġi inkluża bħala sustanza attiva fl-Anness I mad-Direttiva u biex tiġi trasposta d-Direttiva tal-Kummissjoni 2007/70/KE tad-29 ta' Novembru 2007 li temenda d-Direttiva 98/8/KE tal-Parlament Ewropew u tal-Kunsill biex jiġi inkluż d-dijossidu tal-karbonju bħala sustanza attiva fl-Anness IA mad-Direttiva.

(3) Dawn ir-regolamenti għandhom jidhlu fis-seħh fl-1 ta' Novembru, 2009.

**PESTICIDES CONTROL ACT
(CAP. 430)**

Biocides (Amendment) (No. 2) Regulations, 2008

IN exercise of the powers conferred by articles 4 and 5 of the Pesticides Control Act, the Minister for Resources and Rural Affairs, in consultation with the Prime Minister and with the Minister for Social Policy, has made the following regulations:-

1. (1) The title of these regulations is the Biocides (Amendment) (No. 2) Regulations, 2008 and they shall be read and construed as one with Biocides Regulations, 2004, hereinafter referred to as “the principal regulations”. Title and scope.

(2) The scope of these regulations is to transpose Commission Directive 2007/69/EC of 29 November 2007 amending Directive 98/8/EC of the European Parliament and of the Council to include difethialone as an active substance in Annex I thereto and to transpose Commission Directive 2007/70/EC of 29 November 2007 amending Directive 98/8/EC of the European Parliament and of the Council to include carbon dioxides as an active substance in Annex IA thereto.

(3) These regulations shall enter into force on 1st November, 2009. Commencement.

2. Schedule III to the principal regulations shall be amended as follows:- Amends Schedule III to the principal regulations.

(a) immediately after the words “SCHEDULE III” there shall be inserted the words “Part 1”;

(b) immediately after item 2 there shall be added the following new item:-

(c) immediately after Part 1 in Schedule III as renumbered in the principal regulations, there shall be added the following new Part:-
