BIS-SAHHA tas-setgħat mogħtija minn artikli 4 u 5 ta' l-Att dwar il-Kontroll tal-Pestičidi, il-Ministru għar-Riżorsi u l-Affarijiet Rurali, wara li kkonsulta mal-Prim Ministru u mal-Ministru għall-Politika Soċjali, għamel dawn ir-regolamenti li ġejjin:-

1. It-titolu ta' dawn ir-regolamenti huwa Regolamenti li Jimplementaw ir-Regolament (KE) ta' l-2009 dwar l-Ogħla Livelli ta' Residwi ta' Pestičidi fi Prodotti li joriġinaw minn Pjanti u Annimali. Titolu.

2. Dawn ir-regolamenti jimplimentaw id-disposizzjonijiet ta' Artikli 30, 31, 34 u 38 tar-Regolament (KE) Nru. 396/2005 tal-Parlament Ewropew u tal-Kunsill tal-23 ta' Frar 2005 dwar il-livelli massimi ta' residwu ta' pestiçidi fi jew fuq ikel u għalf li joriġina minn pjanti u annimali u jemenda d-Direttiva tal-Kunsill 91/414/KEE.

3. L-Awtorità Maltija dwar l-i*Standards* hija l-awtorità kompetenti msemmija fl-Artiklu 38 tar-Regolament (KE) Nru. 396/2005. Twaqqif ta' l-Awtorità Kompetenti.

4. Is-sanzjonijiet applikabbli għall-ksur tad-disposizzjonijiet tar-Regolament (KE) Nru. 396/2005 għandhom ikunu daww imsemmija fl-artiklu 9 ta' l-Att dwar il-Kontroll tal-Pestičidi. Penali.

**PESTICIDES CONTROL ACT
(CAP. 430)****Maximum Residue Levels of Pesticides in Produce of Plant
and Animal Origin (Implementation of EC Regulation)
Regulations, 2009**

IN exercise of the powers conferred by articles 4 and 5 of the Pesticides Control Act, the Minister for Resources and Rural Affairs, in consultation with the Prime Minister and the Minister for Social Policy, has made the following regulations:-

Citation.

1. The title of these regulations is the Maximum Residue Levels of Pesticides in Produce of Plant and Animal Origin (Implementation of EC Regulation) Regulations 2009.

2. The regulations implement the provisions of Articles 30, 31, 34 and 38 of Regulation (EC) No 396/2005 of the European Parliament and of the Council of 23 February 2005 on maximum residue levels of pesticides in or on food and feed of plant and animal origin and amending Council Directive 91/414/EEC.

Establishment of the
Competent Authority.

3. The Malta Standards Authority is the competent authority within the meaning of Article 38 of Regulation (EC) No. 396/2005.

Penalties.

4. The sanctions applicable for infringement of the provision of Regulation (EC) No. 396/2005 shall be those provided for in article 9 of the Pesticides Control Act.
