PRODUCT SAFETY ACT (CAP. 427)

Dangerous Substances and Preparations (Amendment) Regulations, 2009

IN exercise of the powers conferred by articles 38 to 40 of the Product Safety Act, the Minister of Finance, the Economy and Investment, on the advice of the Malta Standards Authority, has made the following regulations:-

- The title of these regulations is the Dangerous Substances Citation. and Preparations (Amendment) Regulations, 2009, and they shall be read and construed as one with the Dangerous Substances and s.L. 427.28 Preparations Regulations, hereinafter referred to as "the principal regulations".
- These regulations implement the provisions of Article 56 scope. of Regulation (EC) No 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006.
- In the first indent of regulation 6.2 of the principal Amends regulations, for the words "Annex I to Directive 67/548/EEC" there regulation 6 of the principal shall be substituted the words "Part 3 of Annex VI to Regulation (EC) regulations. No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on the classification, labelling and packaging of substances and mixtures".

- (2) In regulation 6.3 of the principal regulations, for the words "Annex I to Directive 67/548/EEC" there shall be substituted the words "Part 3 of Annex VI to Regulation (EC) No 1272/2008 of the European Parliament and of the Council of 16 December 2008 on the classification, labelling and packaging of substances and mixtures".
