**Regolamenti tal-2009 li jemendaw it-Tieni Skeda li tinsab
mal-Att dwar l-Eko-Kontribuzzjoni**

BIS-SAHHA tas-setgħat mogħtija bl-artikoli 3(1) u 13(ċ) tal-Att dwar l-Eko-Kontribuzzjoni, il-Ministru għar-Riżorsi u Affarijiet Rurali, bi ftehim mal-Ministru tal-Finanzi, l-Ekonomija u Investiment, għamel dawn ir-regolamenti li ġejjin:—

1. It-titolu ta' dawn ir-regolamenti hu Regolamenti tal-2009 li jemendaw it-Tieni Skeda li tinsab mal-Att dwar l-Eko-Kontribuzzjoni, u dawn għandhom jinqraw u jiftiehmha waħda mat-Tieni Skeda, hawn iżjed 'il quddiem imsejja "l-Iskeda". Titolu.

2. L-Iskeda għandha tiġi emendata kif ġej: Jemenda l-Iskeda.

(a) minflok il-kliem "(Artikolu 9A)" għandhom jidhlu l-kliem "(Artikolu 3(1))"; u

(b) fin-nota f'tarf l-Iskeda, minflok il-kliem "mill-1 ta' Jannar, 2010." għandhom jidhlu l-kliem "mill-1 ta' April, 2010."

**ECO-CONTRIBUTION ACT
(CAP. 473)****Eco-Contribution Act (Amendment of Second Schedule)
Regulations, 2009**

IN exercise of the powers conferred by articles 3(1) and 13 (c) of the Eco-Contribution Act, the Minister for Resources and Rural Affairs, in concurrence with the Minister of Finance, the Economy and Investment, has made the following regulations:–

Title.

1. The title of these regulations is the Eco-Contribution Act (Amendment of Second Schedule) Regulations, 2009, and they shall be read and construed as one with the Second Schedule to the Eco-Contribution Act, hereinafter in these regulations referred to as “the Schedule”.

Amends the Schedule.

2. The Schedule shall be amended as follows:

(a) for the words “(Article 9A)” there shall be substituted the words “(Article 3(1))”; and

(b) in the footnote thereto, for the words “1st January, 2010.” there shall be substituted the words “1st April, 2010.”.
