

REGULATION

According to the hunting tourism for the foreign citizens
in the Republic of Moldova

1. General notions.

1. Regulation according to the hunting tourism for the foreign citizens in the Republic of Moldova (in continuation of the Regulation) establishes the mode and conditions of effectuation of hunting of foreign citizens in the hunting areas of the Republic of Moldova.

2. The following discretions of the present Regulation are obligatory for all foreign citizens who

effect hunting in the Republic of Moldova and for the benefits of the hunting grounds.

3. In sense of the present Regulation are defined next principal notions:

- a. hunting;
- b. game;
- c. control of hunting;
- d. trophies of hunting;

II. The attribution of the right of hunting.

4. The right of hunting with fire-arms on the territory of the Republic of Moldova accords inclusive persons who do not permanent reside in republic.

5. In staple of certificate for the right of hunting of foreign citizens serve:

- a. the card of hunter (member of AHFM);
- b. permit (sheet) card of harvest;
- c. confirmation of permit to carry the weapon;
- d. the contract of hunting covenanted with beneficiary;

6. In the card of hunter it is obligatory to be indicated consignments considering results of the hunting exam, defrayal for the membership and hunting tax for the current year, payment for realization of compulsory participation by working and registration of the hunting fire-arm. If something is missed, the hunting card is void.

7. To confirm the right of hunting foreign citizen has to execute next requirements:

- a. to be the member of the hunting association of his native country and to confirm this attribute;
- b. to keep in a legal way permit to carry the weapon in his country and to confirm it;
- c. the weapon must be registered in permit to carry the weapon;
- d. to be the member of the Association of hunters and fishermen of the Republic of Moldova;
- e. to possess the Contract of medicine ensuring of the European standard;
- f. to covenant the Contract of participation in hunting with beneficiary of the hunting ground;

8. In the base of the Contract of participation in hunting beneficiary liberates to foreign citizen the permit of hunting;

9. Foreign citizen has the right to participate in hunting only with its personal weapon.

10. Is admitted to introduce in country some limited quantities of cartridges stipulated by the party of hunting (up to 200 units/1 hunter). The organizer of hunting, confirming the contract, will give to the customer necessary number of cartridges instead of payment.

11. Hunting weapon and applied ammunition can be introduced in the Republic of Moldova in the base of Contract of participation in hunting, the respective permit liberated by the ministry of internal affairs and corresponding with respective providence of the customs regime and regulations stipulated in the Customs code of the Republic of Moldova and other legislative and normative acts.

12. The weapon is introduced in country in the customs regime with the terms up to three years and can't be alienated, sold, transmitted or borrowed customs organ.

13. Foreign citizen assumes obligatory to take out from the Republic of Moldova the identified weapon up to the expiration of ground established without any modification.

14. The legislation of the Republic of Moldova permits introduction in country only individual weapon and applied ammunition stipulated in State Cadastre of the weapon.

15. For the period fixed by the common agreement in the Contract of participation in hunting foreign citizen liberates the card of hunter / member of AHFM for 1 year, with colored photo.

III. EFFECTUATION of hunting.

16. It considers the hunting sport activity of tracing with the purposes of gaining, following and proper gathering of animals and birds that are taking place in natural conditions.

17. The hunting effectuates in terms stabilized by legislation in vigor for species of mammals and birds.

18. The terms of hunting are stabilized for every species of hunting (confirming the Laws of Animal life):

1. Deer, elk and ram	-	01 September - 31 December
2. Goat	-	15 May - 15 October
3. Roe deer	-	01 September-31 December
4. Wild boar	-	01 August - 31 December
5. Hare	-	01 November-31 December
6. Fox	-	15 September - 01 March

Birds:

1. Pigeon	-	01 August - 01 October
2. Goose, duck, bald-coot	-	15 August - 31 December
3. Pheasant	-	01 October - 31 December

19. Is permitted hunting with dogs breed trained and registered in the card of hunter with indicating breed, sex, age, weight, number/name.

20. In the Contract of participation in hunting of foreign citizen are stipulated services and taxes, participation of the representative of beneficiary, participation of drover and guide, of hunting guardian and auxiliary worker, translator etc.

IV. Hunting tariffs.

21. Is considered hunting trophy: antler with skull or parts of skull of cervine and cattle, fangs of wild boar, skins and skulls of bears, wolves, lynxes, wild cat, and skulls of foxes, badger and raccoon. These are trophies with elite value and are named conventional. Another category is formed by unconventional trophies: canine of deer and fallow-deer, wolf, otter and fox, hair from "beard" of black goat, from mane of wild boar, deer and badger, "writer's feather" of woodcock, snipe and blackcock, skins of mammals, birds.

22. Hunting trophies legal gained (antlers, skulls, fangs etc.) are property of physical persons (foreign citizens who gained them).

23. For the gained trophies (linear measures of upper jaw of red deer (*Cervus elaphus*), fangs of wild boar etc.) and for the trophies which were awarded by golden, silver and bronze medals foreign citizen will pay tax that is stipulated in the Contract of participation in hunting.

24. The foreign citizen has the right to export hunting trophies of the animals collected in a legal way, if they are declared in a fixed mode of legislation in vigor.

V. Responsibilities and penalties.

25. The foreign citizen who is participating in hunting in the hunting areas of the Republic of Moldova has administrative, penal and civil responsibility confirming the legislation in vigor.

26. The foreign citizen is bound to recover prejudices done to the fauna and other nature with his illicit actions.

27. In the Contract of participation in hunting will be foreseen penalty for the injured and uncompensated specimens, for the wrong shoot, for the non-user of the right to shoot at the command and other cases.

**Tariffs and terms fixed for the collection
of game in the hunting season 2006**

Annual tax of adherence at the AHFM of foreign citizens is fixed statutory in amount of EUR. The tax of adherence at the AHFM of foreign citizens for 3 days of hunting is fixed statutory in amount of 150 EUR.

The execution of legal formalities - 55 EUR.

Tariffs for bird game

1 hunter/ 1 day

1. Services - transport - 0.5 EUR/km, unexceeding amount of 150 EUR/day;
2. Feeding - a little breakfast - 7 EUR;
3. Dinner-12 EUR;
4. Supper (fixed price with exception of alcoholic drinks) - 15 EUR;
5. Translator - 40 EUR/day;
6. Services of hunting guardian - 25 EUR/day;
7. Drover, auxiliary workers - 10 EUR/ day to every person;
8. For alluring installation (for ducks) - 10 EUR/day;
9. For using trained hunting dogs - 40 EUR/day/ldog;
10. Photo - 15 EUR/day, auxiliary;
- 1 EUR/ 1 colored copy;
11. Video - 30 EUR/day, auxiliary;
- 20 EUR for the montage of film (3 hours);
12. Cultural-artistic program - 30 EUR/person/day;
13. Naturalization of the trophy -100 EUR/ 1 bird;
- 200 EUR/ 1 hare;
- 300 EUR/ 1 composition;
14. Housing: big house in national style - from 20 EUR/1 person/1 day;
hotel - from 30 EUR/1 person/ 1 day;

Hunting on wild birds

	Tariff for organization of hunting (EUR)	Tariff for collection of one's species(specimen/EUR)
Duck	50	2
Goose	100	10
Pheasant	50	5
Snipe	20	0.5
Pigeon	20	0.5
Quail	20	1

Foreign hunter is accompanied by 1 hunting guardian and 1 auxiliary worker.

Terms of hunting fixed for every species of game.

(confirming the Laws of Animal life)

1. Wild boar - 01 November - 31 December
2. Hare - 01 December - 15 January
3. Fox - 15 September - 01 March

For birds:

4. Pigeons - 19 August - 15 October
5. Quail - 19 August - 01 October
6. Goose1 - 01October - 31 December
7. Duck, bald-coot - 19 August - 31 December
8. Pheasant - 01 October - 31 December

Hunting on wild animals

Species of animals	Tariff for organization of hunting (EUR)	Tariff for collection of one's species (specimen/EUR)
Wild boar	100	-
Hare	30	25
Red fox	50	10

Services and taxes for hunting on wild boar.

1. Trophy with fang till 16 cm - 300 EUR;
2. Trophy with fang more than16 cm - 300 EUR+10 EUR;
3. For pigs bigger than 100 kg - 50 EUR + 1 EUR for every kg plus;
4. Wound - 100 EUR;
5. Miss - 50%;
6. For medal trophy - gold + 30%; silver + 20%; bronze + 10%.

NOTE:

- For the paid amount hunter benefits of trophy (fangs, weapons and knives);
- At the individual hunting hunter is secured with 1 guide;
- For every injured and uncompensated specimen hunter must pay 50% from amount of trophy;
- For every miss - 150 EUR;
- In the cases when hunter has a possibility to shoot at the command but won't use it, he will pay 100 EUR to every failure.

In the cases when at hunting ground didn't follow commanded shoot, for respective day hunter must pay only 20% from provided amount, but not less than 50 EUR;

For mixed organized hunting on wild boars, pheasants, hares and foxes foreign citizens accept aforementioned tariffs.
