PROTOCOL¹ BETWEEN THE GOVERNMENTS OF THE FRENCH
REPUBLIC AND THE FEDERAL REPUBLIC OF GERMANY
CONCERNING THE ESTABLISHMENT OF AN INTERNA-
TIONAL COMMISSION TO PROTECT THE SAAR AGAINST
POLLUTION

The Governments of the French Republic and the Federal Republic of Germany,

Desiring to establish the procedure for applying article 8 of annex 8 of the Treaty for the settlement of the question of the Saar, signed at Luxembourg on 27 October 1956,²

Have agreed as follows:

Article 1. The signatory Governments shall establish an International Commission to protect the Saar against pollution.

Article 2. The Commission established by virtue of article 1 is intended to ensure co-operation between the competent agencies of the two signatory Governments with a view to protecting the waters of the Saar against pollution.

To this end, the Commission may:

- a) prepare, commission and avail itself of the results of all inquiries necessary for determining the nature, extent and origin of the pollution;
- b) propose to the signatory Governments suitable measures for protecting the Saar against pollution.

The Commission shall also concern itself with all other matters which the signatory Governments refer to it by common agreement.

Article 3. The Commission shall consist of delegates appointed by the signatory Governments.

Each Government shall appoint not more than four delegates, one of whom shall be the head of the delegation.

Each Government may appoint experts; the Commission shall determine the conditions governing their participation in its work.

Article 4. The Chairmanship of the Commission shall rotate every two years among the heads of the individual delegations.

Article 5. The Commission shall hold one regular session each year, which shall be convened by the Chairman.

In addition, a special session of the Commission may be convened by the Chairman on the proposal of one of the signatory Governments.

The Chairman shall draw up the agenda. Each delegation may have the items it wants discussed included in the agenda. The agenda shall be in the hands of the delegations one month before the date of the meeting.

Article 6. Each delegation shall have one vote.

Article 7. Decisions of the Commission shall be adopted by common agreement.

Article 8. The Commission may establish working groups for the consideration of particular problems. These groups shall consist of delegates and experts appointed as provided in article 3.

The Chairman of each working group shall be a delegate selected by the Commission.

Article 9. The Commission shall establish such relations as it sees fit with all bodies having jurisdiction in water pollution matters.

Article 10. Each signatory Government shall bear the cost of its representation and the cost of analyses and studies carried out in its territory.

Expenditure of common interest shall be apportioned between the French Republic and the Federal Republic of Germany according to the procedure proposed by the Commission and laid down by the Governments.

Article 11. The signatory Government shall settle through the diplomatic channel disputes concerning the application or interpretation of this Protocol.

Article 12. This Protocol shall apply to *Land Berlin* unless the Government of the Federal Republic of Germany makes a declaration to the contrary to the Government of the French Republic within three months from the date of entry into force of the present Protocol.

Article 13. The working languages of the Commission shall be French and German.

Article 14. This Protocol shall enter into force on a date determined by the signatory Governments by common agreement.

Upon the expiration of a period of three years after its entry into force, it may be denounced at any time by either of the signatory Governments subject to three months' notice.
