



# AGRICULTURE QUARANTINE (FEES) REGULATIONS 2007

PURSUANT to section 20(g) of the Agriculture Quarantine Act 1984 the Cabinet of Ministers makes the following regulations.

## 1 Title

These are the Agriculture Quarantine (Fees) Regulations 2007.

#### 2 Fees

The fees prescribed for the purposes of the Agriculture Quarantine Act 1984 are set out in the Schedule.

### 3 Revocation

The following Regulations are revoked:

- (a) Animal Quarantine (Fees) Regulations 1991
- (b) Agricultural Quarantine Phytosanitary Certificates (Fees) Regulations 1993
