Inhibitor substances declared to be agricultural compounds

Order

- 1 **Title**
This order is the Agricultural Compounds and Veterinary Medicines (Inhibitor Substances) Order 2022.
- 2 **Commencement**
This order comes into force on 18 July 2022.

3 Inhibitor substances declared to be agricultural compounds

- (1) An inhibitor substance is an agricultural compound for the purposes of the Agricultural Compounds and Veterinary Medicines Act 1997 if, for the purposes of mitigating the adverse impacts of an agricultural activity on the environment, on sustainability, or on climate change, it is—
 - (a) used or intended for use in the direct or indirect management of plants or animals; or
 - (b) applied to a place on or in which there are plants or animals; or
 - (c) applied to the feed or water of plants or animals.
- (2) In this order, **inhibitor substance** means—
 - (a) a substance listed in the Schedule; and
 - (b) an ester, isomer, or salt form of a substance listed in the Schedule.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 18 July 2022, declares the inhibitor substances listed in the *Schedule* to be agricultural compounds for the purposes of the Agricultural Compounds and Veterinary Medicines Act 1997 (the **Act**) if they are used for the purposes of mitigating the adverse impacts of an agricultural activity on the environment, on sustainability, or on climate change.

The effect of this order is to regulate inhibitor substances as agricultural compounds to manage any risk to public health, trade in primary products, animal welfare, or bio-security associated with the use of those substances.

On 18 July 2022, amendments to the Agricultural Compounds and Veterinary Medicines (Exemptions and Prohibited Substances) Regulations 2011 also come into force. Those amendments permit inhibitor substances that are in use on the commencement date to be imported, manufactured, sold, or used as agricultural compounds without registration under section 21 or 27 of the Act for a transitional period of 2 years starting on the commencement date.

Regulatory impact statement

The Ministry for Primary Industries produced a regulatory impact statement on 15 July 2020 to help inform the decisions taken by the Government relating to the contents of this instrument.
