Order

1 Title

This order is the Fisheries (Schedules 5, 5A, and 6) Order 2010.

2 Commencement

This order comes into force on 1 October 2010.

3 Schedule 5 of Fisheries Act 1996 amended

Schedule 5 of the Fisheries Act 1996 is amended by inserting "Patagonian toothfish (*Dissostichus eleginoides*)" in its appropriate alphabetical order.

4 Schedule 5A of Fisheries Act 1996 amended

Schedule 5A of the Fisheries Act 1996 is amended by adding "STN1".

5 Schedule 6 of Fisheries Act 1996 amended

Schedule 6 of the Fisheries Act 1996 is amended by inserting the items set out in the Schedule of these regulations in their appropriate alphabetical order.

Schedule New items inserted in Schedule 6 of Fisheries Act 1996

Stock Requirements Area All New Zealand Bladder kelp (Macrocystis A commercial fisher may pyrifera) fisheries waters return bladder kelp to the waters from which it was taken if it was taken as the inevitable consequence of the taking of other fish, aquatic life, or seaweed in accordance with a current fishing permit.

Stock Area Requirements

Patagonian toothfish (Dissostichus eleginoides)

All New Zealand fisheries waters

A commercial fisher may return any Patagonian toothfish to the waters from which it was taken if—

- (a) the Patagonian toothfish is likely to survive on return; and
- (b) the return takes place as soon as practicable after the Patagonian toothfish is taken; and
- (c) in the case of a trawl-caught Patagonian toothfish, it is released only in the presence of an observer.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 October 2010, amends Schedules 5, 5A, and 6 of the Fisheries Act 1996.

The amendments insert references to—

- Patagonian toothfish into Schedule 5:
- southern bluefin tuna into Schedule 5A:
- Patagonian toothfish and bladder kelp into Schedule 6.

1 Title

This order is the Fisheries (Schedules 5, 5A, and 6) Amendment Order 2010.

2 Commencement

This order comes into force on 30 September 2010.

3 Principal order amended

This order amends the Fisheries (Schedules 5, 5A, and 6) Order 2010.

4 New clause 2 substituted

Clause 2 is revoked and the following clause substituted:

"2 Commencement

- "(1) Clause 4 of this order comes into force on 1 October 2011.
- "(2) The rest of this order comes into force on 1 October 2010."

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 30 September 2010, amends the Fisheries (Schedules 5, 5A, and 6) Order 2010 (**principal order**). The amendment replaces the commencement clause to clarify that clause 4 of the principal order comes into force on 1 October 2011. Clause 4 inserts a reference to southern bluefin tuna into Schedule 5A of the Fisheries Act 1996.
